MEDICINE BOW - KYLE ROAD:

A motion was made by Jackson, Seconded by Cheesbrough and carried whereby the Board of Commissioners hereby submit the following request to the Wyoming State Highway Department, to-wit:

Road
The Board of County Commissioners of Carbon County, Wyoming, in meeting duly assembled at Rawlins, Wyoming, this 2nd day of July, A. D. 1957, do hereby request the Wyoming State Highway Department to consider the construction of a new highway or road, to become and be a part of the secondary system of the roads of the State of Wyoming, from Medicine Bow, Wyoming, south to Kyle, Wyoming, in Carbon County, Wyoming.
The said Board of County Commissioners of Carbon County, Wyoming, does hereby and herein designate the proposed road construction as designated above as its preferred choice for road construction within Carbon County, to become a part of the State Secondary Highway System and does further request the Wyoming State Highway Department to give this proposed construction top priority in its planning, designation and construction of roads and highways in the Wyoming State Secondary System.
Dated at Rawlins, Wyoming, this 2nd day of July, A. D. 1957.
