COUNTY FAIR BOARD: The resignation of Mark Heward was accepted by the Board, Mr. Heward having resigned because of ill health. John Cheesbrough was appointed to fill the un-expired term of Mr. Heward which will terminate on February 2, 1961.

MEDICINE BOW-NORTH ROAD-PROJECT S-0405(2) CARBON COUNTY: A Quit Claim Deed was presented to the Board on exchange of lands with the Union Pacific Railroad Company on above mentioned right of way. A motion was made by Jackson, seconded by Cheesbrough and carried whereby the following Resolution was adopted, to-wit:

RESOLUTION

WHEREAS, Union Pacific Railroad Company, by deed of easement dated September 10, 1952, granted to the County of Carbon, State of Wyoming, a perpetual easement solely for highway purposes over and across certain lands of said Union Pacific Railroad Company of which the following described land is a portion:

All that portion of Section 5, Township 22 North, Range 78 West of the Sixth Principal Meridian bounded by parallel lines 200 feet apart being 125 feet on the left or westerly side and 75 feet on the right or easterly side when measured at right angles or radially to the following described center line of highway, and by the prolongation of said parallel lines to the legal boundaries of the above described lands, and by those portions of the legal boundaries intercepted between said parallel lines as prolonged;

Beginning at a point on the south boundary of said Section 5 from which the southwest corner thereof bears North 89° 37' West a distance of 1,291.1 feet;

thence North 0° 21' East a distance of 1,928.1 feet to the point of beginning of a 4° 00' circular curve to the right the radius of which is 1,432.4 feet;

thence along said curve through a central angle of 82° 10' for a distance of 2,054.2 feet;

thence North 82° 31' East a distance of 410.4 feet to the point of beginning of a 3° 30' circular curve to the left the radius of which is 1,637.0 feet;

thence along said curve through a central angle of 41° 08' for a distance of 1,175.2 feet;

thence North 41° 23' East a distance of 1,511.0 feet, to a point on the north line of said Section 5, from which the northeast corner thereof bears South 88° 39' East a distance of 348.9 feet;

containing an area of 32.5 acres, more or less;

said deed having been recorded September 19, 1952, in Book 317, at Pages 47 to 50, in the records of the County of Carbon, State of Wyoming; and

WHEREAS, the County of Carbon, State of Wyoming, has abandoned the lands above described for highway purposes; and

WHEREAS, said deed dated September 10, 1952, whereby

said easement in said land for highway purposes was acquired, contains a provision stating that in the event the said County of Carbon, State of Wyoming, shall abandon said land for public highway purposes, the rights granted in said deed shall cease and determine, and the title to said land shall be relieved of the burden of said easement; and

WHEREAS, said Union Pacific Railroad Company has tendered to the County of Carbon, State of Wyoming, a proposed deed whereby the said County of Carbon, State of Wyoming quit-claims to said Union Pacific Railroad Company all right, title and interest in the land abandoned as aforesaid for highway purposes; and

WHEREAS, it is deemed proper, in consideration of the premises, that the County of Carbon, State of Wyoming, should execute said quitclaim deed;

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING,

That the County of Carbon, State of Wyoming, execute and deliver to Union Pacific Railroad Company the aforementioned deed quitclaiming the above described property to said Union Pacific Railroad Company, and that the Chairman of said Board of County Commissioners of the County of Carbon, State of Wyoming, be and hereby is authorized, empowered, and directed to execute said deed in behalf of said County, and that the County Clerk be and hereby is authorized and directed to attest said deed, to attach thereto a copy of this resolution, and to deliver said deed to said Union Pacific Railroad Company.




