COUNTY WELFARE BOARD: A motion was made by Jackson, seconded by Cheesbrough and carried whereby Henry Jones of Hanna, Wyoming was appointed to a three year term on the County Welfare Board, commencing January 7, 1958, to succeed Walton E. France, whose term expired.

FOREST RESERVE FEES: A warrant in the amount of \$26,212.39 was received by the County Treasurer from the State. In compliance with Sections 18-403 and 18-405 W C S 1945, a motion was made by Jackson, seconded by Cheesbrough and carried, whereby the Forest Reserve Fees were distributed as follows:
