STATE PROJECT SC-CFM 4700 KORTES ROAD, CARBON COUNTY:

A motion was made, seconded and carried whereby the following Resolution was unanimously adopted.

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

KORTES ROAD:

From the Natrona County line in Sec. 2, T. 28 N., R. 83 W., thence southerly for approximately 4.0 miles.

Grading, Draining, Base course surfacing, Inverted Penetration and Chip Seal.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
