A motion was made by Orton, seconded by Olsen and carried whereby the following Resolution was adopted.

RESOLUTION

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF CARBON, STATE OF WYOMING, APPROVING INDUSTRIAL ADDITION TO THE CITY OF RAWLINS:

WHEREAS, the Mayor and City Council of the City of Rawlins, Carbon County, Wyoming, at a regular meeting thereof on December 9, 1957, pursuant to the terms of 29-206 and 29-302 of the Wyoming Compiled Statutes of 1945 extended the City Limits of said City to include Industrial Addition thereto, and accepted and confirmed the dedication to public use of the streets and driveways laid out therein, and

WHEREAS, said Industrial Addition is platted over land adjacent to the City of Rawlins, Carbon County, Wyoming, and therefore pursuant to Section 29-1102 requires joint approval of the Board of County Commissioners and the legislative body of said City of Rawlins.

NOW, THEREFORE, the Board of County Commissioners of the County of Carbon, State of Wyoming, pursuant to the terms of Section 29-1102 of the Compiled Statutes of 1945 do hereby approve the plat of Industrial Addition to the City of Rawlins, Carbon County, Wyoming, submitted by Rawlins Chamber of Commerce, a Wyoming corporation, the owner and proprietor thereof, which Addition is platted over land adjacent to said City and within one mile of the boundaries thereof and is described as follows, to-wit:

West of the N $\frac{1}{2}$ corner of said Section 15; thence S51°16'E, 1523.12 ft. to a point on the East side of NE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 15 that is 950.00 ft. south of the N $\frac{1}{2}$ corner of said Section 15; thence S0°09'E, 372.05 ft. to the Southeast corner of NE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 15; thence N89°45'W, 1312.51 ft. to the Southwest corner of the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of said Section 15; thence North 1322.22 ft. to the point of beginning; EXCEPTING a 400 ft. wide strip of land in the NE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 16 and NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 15 to be reserved by the City of Rawlins, Wyoming, for right-of-way for U.S. Highway No. 287 and a stock driveway and which is described as follows: Beginning at a point on the North side of Section 16 that is S89°43'W, 507.44 ft. from the NE corner of said Section 16; thence N89°43'E, 434.72 ft. along the North line of said Section 16; thence S22°46'E, 1436.30 ft. to a point on the South line of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 15, that is S89°54'E, 476.16 ft. from the Southwest Corner of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 15; thence N89°54'W, 434.08 ft. along the South line of the NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 15 to a point that is 42.08 ft. Easterly of the Southwest corner of NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 15; thence N22°46'W, 1436.94 ft. to the point of beginning; all of preceding descriptions being in T21N, R87W of the 6th P.M., Carbon County, Wyoming.

HOSPITAL BOARD APPOINTMENT: A motion was made by Olsen to re-appoint Chris Keldsen to the Memorial Hospital Board. Salisbury made a motion that Kenneth Larkin be appointed to this Board. There being no second to either motion, a coin was tossed and Kenneth Larkin won the toss. Thereupon a motion was made by Orton, seconded and carried that Kenneth Larkin be appointed for a five year term, commencing July 11, 1959 and terminating July 11, 1964.

COUNTY AGRICULTURAL ADVISOR: Mr. Orville Ashman of the Wyoming University Extension Service presented an Agreement whereby wages and expenses for a County Agricultural Advisor would be provided from July 1, 1959 until June 30, 1961, county share to be \$3840.00 salary and \$560.00 expenses. The Board decided to approve this agreement. The terms of this agreement are on file in the Office of the County Clerk.

There being no further business, the meeting was adjourned.
