
The Board reviewed the assessment as made to date, and being advised of the facts, made the following changes:

James Chapman, Rawlins: Raised cattle from none to 16 bulls and 400 head stock cattle.




MINUTES, MEETING OF JUNE 13, 1960

The Board of County Commissioners of Carbon County, Wyoming met as a Board of Equalization in Room 104 of the Carbon County Courthouse at the hour of 2:00 P.M., on the 13th day of June, 1960, as provided by law, Title 39, Chapter 4, Wyoming Statutes, 1957. Present were Mr. George Salisbury and Mr. John Orton, absent Mr. Pete Olsen. R. A. Hakala, County Assessor, acted as Clerk of the Board. Mr. Dudley D. Miles, County Attorney, was present to advise the Board on matters of law.


In the matter of the corrected assessments the Assessor advised the Board that Mr. James Chapman appeared to clarify the matter of his cattle, advising the Assessor that he had acquired a number of cattle from Montana, and had purchased the Harry Lambertson outfit. The Montana cattle came into Wyoming in April, and numbered 172 head, some of which had perished since arrival. In the matter of the adjustment of the Safeway Stores, Inc., assessment, Mr. Ball of Safeway Stores met with the Assessor before the meeting of the Board and being advised of the facts, agreed that the assessment as corrected was satisfactory.

A letter from the law firm of Guy and Phelan, dated May 23, 1960, and received by the Board on May 24, 1960, was read. The letter is attached to and becomes a part of these minutes. The Board, being advised of the position of the County by their attorney, decided, upon motion by Mr. Salisbury, seconded by Mr. Orton, to sustain the position of the County, and denied the request as presented in the letter. The Assessor was instructed to adhere to the District Court decision as nearly as possible and to assess the property in question as directed by the Court.

The Board continued its session until 5:00 P.M. and adjourned.
