COLORADO INTERSTATE GAS COMPANY ACCESS ROAD: Mr. Paul McCordle and D. H. McCorkle of the Colorado Interstate Gas Company met with the Board to discuss the access road from Highway 30 to their pumping station, a distance of 1.07 miles more or less. The Commissioners decided to meet with the owners of the land on which the proposed road is located relative to obtaining an easement for Carbon County.

Thereupon the Board adjourned until the following day, all members present.

February 8th, 1961. A delegation from Snake River and Encampment met with the Commissioners together with Highway Officials and Forest Officials, requesting an all-weather road from Encampment to Slater. The Commissioners agreed to give possible consideration to the project pending availability of funds.

SALE OF COUNTY PROPERTY: Lots 19 to 24 inc. Block 19, Third Merrell Addition to the City of Rawlins were sold to Ernest "A" Martinez, Rawlins, Wyo., for - - - \$100.00.

JUSTICE OF THE PEACE BOND; for Bryon T. Knowles of Baggs was approved in the amount of \$1500.00.

TAX REBATE ORDER NO. 1645 was granted to John H. Bell of Iron Mountain, Wyoming in the amount of \$182.80, Account of Erroneous Assessment.

John and Don Kortes representing the Leo Farm Bureau met with the Board relative to road improvements in that vicinity, no definite action was taken.

COUNTY FAIR BOARD: John Cheesbrough, Rawlins was re-appointed to a five year term on the County Fair Board.

Members of the Rawlins Fire Department met with the Board and requested financial aid for the construction of a truck to carry rescue equipment and highway emergency rescue kits. The Board agreed to assist in the cost of this equipment.

A motion was made by Commissioner Patton, seconded by Ogburn and carried whereby the following Resolution was adopted.

#### R E S O L U T I O N

WHEREAS, the Colorado Interstate Gas Co., has requested the Board of County Commissioners of Carbon County to secure the right of way for the Colorado Interstate Gas Co., Access Road described as follows:

A strip of land 100 ft. in width, being 50 ft. on each side of the center line described as follows:

Beginning at a point, on the South Right-of-Way line of U.S. Highway No. 30, which point is 1493.4' East, thence 372' N. 0° 15' E. from the Southwest corner of Section 24, Township 21 North, Range 86 West, as Station 0 00, thence coursing S. 0° 15' W. 372' to the line between said Section 24 and 25, comprising 0.854 acres, more or less; thence S. 0° 15' W. 5280' to the line between Sections 25 and 36, Township 21 N., Range 86 W., comprising 12.1 acres more or less; total length 5652 feet, being 1.07 miles, more or less, and,

WHEREAS, James A. and Mary Helen Chapman, owners of the above described land have offered to give the County of Carbon an Easement, and

WHEREAS, The Board deem the public interest requires that said road be established as a county road.

NOW, THEREFORE BE IT RESOLVED; That the Board of County Commissioners of Carbon County, Wyoming, do hereby declare their intention to establish said road. The plat of above proposed road is on file in the Office of County Clerk.

STATE EXAMINERS' REPORT: The annual report of the County Offices was reviewed by the Board and all officers were instructed to comply with the recommendations of the Examiners.

There being no further business the meeting was adjourned.
