SLATER-RIVERSIDE ROAD: The Commissioners authorized the Wyoming State Highway Department to proceed with a survey on the extension of the Slater-Riverside road, F. A. S. 0401, from a point on the Colo. - Wyo. State Line near Slater, Colorado, thence northeasterly on proposed survey of road.

PETITION - SPECIAL CEMETARY DISTRICT: A petition was received by the Commissioners from residents of Dixon and Savery requesting the establishment of a special cemetary district and for calling a special election for that purpose. The area to be included in the proposed district is described as follows:

Beginning at the SW corner of Lot 4, Sec. 19, T 12 N, R 90 W of the 6th P. M.; thence northerly along the range line common to R 90 and 91 to the NW corner of Sec. 6, T 16 N, R 90 W of the 6th P.M.; thence easterly along said township line to the NE corner of Sec. 1, T 16 N, R 87 W of the 6th P.M.; thence southerly along the range line common to R 87 and 86 to the SE corner of Lot 1, Sec. 24, T 12 N, R 87 W of the 6th P. M.; thence in a westerly direction along the state line common to the States of Colorado and Wyoming to the point of beginning. The Board instructed the County Attorney and County Clerk to proceed with a special election as provided by law, specifically, Section 35-388, Wyoming Statutes, 1957.

Several matters of routine County business was disposed of.

Thereupon the Board adjourned.
