Horses from 0 to 15 head
Mules from 0 to 9 head
Wagons, etc. from 0 to \$200
Saddles, etc. from 0 to \$75

The Clerk was instructed to notify the parties of the action by the Board by registered mail. The Board completed its review of the assessment for the year 1961 and adjourned at 4:00 P.M. to meet again on the 12th of June, 1961.
