

July 6, 1962 The Board resumed its session, all members present, Salisbury Chairman.

CARBON COUNTY MUSEUM BOARD: Alex Gordon submitted his resignation as a member of the Board and the term of Kleber H. Hadsell expired as of June 30, 1962. On recommendation of other Board members, Mrs. Jeane Lambertson was appointed to a 3 year term commencing July 6, 1962 and expiring July 6, 1965. P. Edward Daley was appointed to fill the un-expired term of Alex Gordon, commencing July 6, 1962 and ending July 6, 1963.

ABATEMENT IN THE AMOUNT OF \$13.20 was allowed Gladys V. Larsen of Rawlins account double assessment.

A motion was made by Patton, seconded by Sullins and carried whereby the following resolution was adopted.

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, deem the public interest requires that a road be established to be known as the Colorado State Line - Riverside Road, Project S-0401 (1), described as follows:

Commencing at a point on the Wyoming - Colorado State Line situated in the $SE_1/4$, $SE_1/4$, Section 14, Resurvey T. 12 N., R. 89 W. of the 6th P. M., Wyoming, which point bears S. $90^{\circ}04'$ W. a distance of 1,152.30 feet from the southeast section corner of said Section 14; thence running northeasterly a distance of approximately 5.38 miles through Sections 14 and 13, Resurvey T. 12 N., R. 89 W., Sections 18, 7, 8, 17 and 5, Resurvey T. 12 N., R. 88 W., Section 32, T. 13 N., R. 88 W. all of the 6th P. M., Wyoming.

To a point of ending, S. $17^{\circ}37'$ W. a distance of 848 feet from the north boundary of Section 32, T. 13 N., R. 88 W. from which the southeast section corner of said Section 32 bears N. $89^{\circ}59'$ a distance of 1,106.04 feet.

NOW THEREFORE, BE IT RESOLVED, that the said Board do hereby initiate the procedure for the establishment of said road, and declare their intention to establish said road by following out the provisions of Section 24-43, Wyoming, Statutes, 1957, not inconsistent herewith.

COLORADO STATE LINE - RIVERSIDE ROAD, PROJECT NO. S-0401 (1) CARBON COUNTY.

NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN: The Board of County Commissioners of Carbon County, Wyoming, have decided to locate a road to be known as Colorado State Line - Riverside Road as described in the above resolution.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any landowner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said county before noon on the 8th day of August, A. D. 1962, or such road will be established without reference to such objections or claims for damages.


