The Board of County Commissioners met at 10:00 A.M., all members present, Salisbury, Chairman. Minutes of meetings held December 5th and 6th, 1962 were read and approved.

MONTHLY REPORTS of County Officers were audited and placed on file.

## PUBLIC BUILDING BONDS

STATE OF WYOMING )  
COUNTY OF CARBON ) ss.

A regular meeting of the Board of County Commissioners of the County of Carbon, Wyoming, was held at 10:00 o'clock A.M., on Tuesday, the 2nd day of January, 1962, at the regular meeting place of the Board in Rawlins, Wyoming.

The Chairman of said Board called the meeting to order and upon roll call it was found that the following were present:

Thereupon Commissioner Sullins introduced a Resolution providing for the issuance by Carbon County, Wyoming, of its negotiable coupon Public Building Bonds in the aggregate amount of \$84,000, prescribing the form of said bonds and providing for the levy of taxes to pay the principal of and the interest on the same, which Resolution was thereupon read in full and is as follows, to-wit:

R E S O L U T I O N

WHEREAS, at a special election on August 8, 1961, the qualified electors of Carbon County, Wyoming, authorized the issuance of negotiable coupon bonds of said County in the principal sum of \$84,000, for the purpose of providing funds to develop and to acquire lands and other property for a public auditorium, civic center and community building; and

WHEREAS, said bonds were duly advertised for sale and on the 5th day of December, 1961, the Board of County Commissioners awarded said bonds to the highest and best bidders therefor.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:

Section 1. That negotiable coupon bonds of the County of Carbon, in the principal amount of \$84,000, to be designated "Public Building Bonds", be issued for the purpose of providing funds to develop and to acquire lands and other property for a public auditorium, civic center and community building in said County.

Section 2. That said Public Building Bonds shall be dated as of January 1, 1962, shall consist of 84 bonds in the denomination of \$1,000 each, numbered 1 to 84, inclusive, shall mature \$16,000 on January 1 in the year 1963, and \$17,000 on January 1 in each of the years 1964 to 1967, inclusive, and shall bear interest at the rate of 2.70% per annum, payable semi-annually on the 1st day of January and the 1st day of July each year. The principal of and interest on said bonds shall be payable at the office of the County Treasurer, in Rawlins, Wyoming.

Said bonds shall be signed by the Chairman of the Board of County Commissioners, sealed with the seal of said County, and attested by the County Clerk. The interest accruing on said bonds shall be evidenced by interest coupons thereto attached, bearing the facsimile signature of the Treasurer of said County, and when so executed, such coupons shall be the binding obligations of the County according to their import. Should any officer whose signature or facsimile signature appears on said bonds or the coupons thereto attached cease to be such officer before delivery of the bonds to the purchaser, such signature or facsimile signature shall nevertheless be valid and sufficient for all purposes.

Section 3. Said bonds and the coupons to be attached thereto and the registration certificate to appear

thereon shall be in substantially the following form, to-wit:

in lawful money of the United States of America, on the 1st day of January, 19\_\_\_\_, with interest thereon from the date hereof at the rate of two and seventy hundredths per centum (2.70%) per annum, payable semi-annually on the 1st day of January and the 1st day of July each year, as evidenced by coupons attached hereto, both principal and interest being payable upon presentation and surrender of said coupons and this Bond at the office of the County Treasurer, in Rawlins, Wyoming.

This Bond is issued for the purpose of providing funds to develop and to acquire lands and other property for a public auditorium, civic center and community building, in full conformity with the provisions of Title 18, Chapter 5, Article 3 and Title 18, Chapter 10, Wyoming Statutes, 1957, and all other laws thereunto enabling, and it is hereby certified, recited and warranted that all acts, matters and things required to occur, be done and performed, legally to issue this Bond, have duly occurred, happened, been done and performed; that the total indebtedness of said County, including that of this Bond, does not exceed any limit of indebtedness prescribed by the Constitution or laws of the State of Wyoming, and that the issuance of this Bond was duly authorized by the qualified electors of said County at an election duly called and held prior to the issuance hereof.

The full faith and credit of said County are hereby pledged for the punctual payment of the principal and of the interest on this Bond.

IN TESTIMONY WHEREOF, Carbon County, Wyoming, has caused this Bond to be signed by the Chairman of its Board of County Commissioners and attested by the County Clerk, under the seal of said County, and has caused the interest coupons hereto attached to be signed with the facsimile signature of the County Treasurer, as of the 1st day of January, 1962.

Section 4. That said bonds, when so executed, shall be delivered to the purchasers thereof on receipt of the purchase price. Neither the purchasers nor any subsequent holder of any of said bonds shall be responsible for the application of the proceeds of said bonds by said County or any of its officers.

Section 5. That the County Clerk shall endorse on each of said bonds the certificate required by Section 8 of Article XVI of the Constitution and by 18-250, Wyoming Statutes, 1957, and shall sign such certificate in his official character.

Section 6. The interest due on said bonds on July 1, 1962, and, if necessary, the interest and principal due January 1, 1963, shall be advanced from any available fund of the County. For the purpose of reimbursing said fund and paying the interest on said bonds as it shall become due, and for the payment of the principal thereof promptly when due, there shall be levied on all of the taxable property in said County, in addition to all other taxes, direct annual taxes in each of the years 1962 to 1965, inclusive, sufficient to make such reimbursement and to pay such interest and principal promptly as the same become due and payable, respectively.

Section 7. Said taxes shall be computed and ascertained on the assessment and tax rolls and collected by the same officers and in the same manner as other taxes of said County, and shall be known as the "1962 Public Building Bond Tax" and shall be used for the payment of interest and principal of the bonds herein authorized and for no other purpose, and said taxes are hereby appropriated for that purpose, and the amount for each year shall be included in the annual appropriation bill and budget passed and adopted by the Board of County Commissioners in each of said years. The said Board shall do all acts and things necessary fully to carry out the provisions of this Section.

Section 8. It shall be the duty of the Board of County Commissioners of said County, annually, at the time and in the manner provided by law for levying other County taxes, if such action shall be necessary to effectuate the provisions of this Resolution to ratify and carry out the provisions hereof with reference to the levying and collection of taxes; and the Board of County Commissioners shall require the officers of and for said County to levy, extend and collect such taxes in the manner provided by law for the purpose of creating a fund for the payment of the principal of and interest on said bonds, and such taxes, when collected, shall be kept for and applied only to the payment of the interest on and principal of said bonds, as hereinabove specified. Nothing contained in this Resolution shall prevent the use of any other funds available therefor in the payment of the principal of or interest on said bonds, and upon any such payment, the levies herein provided shall be reduced accordingly. In the event any of said tax levies do not produce a sufficient amount to pay the annual interest on and the specified amount of principal of said bonds, the deficiency shall be made up from the general fund of the County and included in the next succeeding tax levy.

Section 9. After said bonds have been issued, this Resolution shall be irrevocable until both the principal of and interest on said bonds shall be fully paid, satisfied and discharged.

Section 10. All resolutions or parts thereof in conflict with this Resolution, are hereby repealed.

Section 11. This Resolution, after its final passage and approval, shall be recorded by the Clerk in a book kept for that purpose in his office, and shall be published in accordance with law.

CENTRAL SCHOOL BUILDING-METAL BOX: The Commissioners examined the contents of the metal box removed from the corner stone in the old Central School Building. A copy of the Wyoming Tribune, dated July 15, 1886, a copy of the Democratic Leader, issued in Cheyenne, Wyoming on July 17, 1886, a letter dated July 21, 1886 signed by Perry L. Smith, ex-auditor of Wyoming Territory, a letter dated July 21, 1886 on J. W. Hugus and Co. Stationary in which the date of the laying of the corner stone was shown as July 21, 1886, this letter was signed by J. C. Davis and J. M. Rumsey, J. O'Connor and C. H. Durant. A sealed envelope containing a poem written by Mrs. Wm. Daley, one 1868 nickel and several advertising cards were contained in the box. The letters indicate that Wm. Daley was Building Superintendent, Hallack & Howard of Denver were General Contractors, Geddis and Seerie of Denver, Colorado were the stone contractors. The contract for building of the School House was \$25,000 and was approved by an act of Governor Warren on February 18, 1886. The Commissioners have decided to deliver the contents of the Box to the Carbon County Museum at the February meeting of the Board of Commissioners.

Thereupon the Board adjourned until the following day.

January 3, 1962. The Board resumed its session, all members present.

#### POLL TAX:

A motion was made by Sullins, seconded by Patton and carried whereby the County Assessor was authorized to proceed with the collection of Poll Tax for 1962 in compliance with W. S. 39-236, 1957.

ABATEMENTS as follows were allowed by the Board.

Mrs. Esther M. Danford, Dixon, Wyo., Abatement \$6.92, Account Erroneous Assessment.

Lewis C. Waldron, Dixon, Wyo., Abatement of \$28.97, Account Erroneous Assessment.

COUNTY DEPOSITORIES: The Commissioners designated the Rawlins National Bank and the First National Bank of Rawlins as County Depositories for 1962.

TRANSFER OF MALT BEVERAGE LICENSE: The Commissioners approved the transfer of Malt Beverage Permit No. 210, which was issued to Dee Gillilan on May 6, 1961 to Consumers Gasoline Co. An Assignment to Consumers Gasoline Co., was signed by Mr. Gillilan and delivered to the Commissioners.

Several road matters were discussed and tabled until the next meeting.

There being no further business the meeting was adjourned.
