COMMISSIONERS PROCEEDINGS  
SPECIAL MEETING

The Board met at 10:00 A.M., all members present, George R. Salisbury, Jr., Chairman.

CALL FOR BIDS: The following bids were received for a new dump truck, as advertised in the Rawlins Daily Times on March 8 and 15, 1962.

The Commissioners decided to keep the old truck and accepted the bid submitted by Sundin Chevrolet Company.

SNAKE RIVER SPUR: A motion was made by Sullins, seconded by Patton and carried, whereby the following resolution was adopted:

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Chapter 99, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows and known as SNAKE RIVER SPUR:

Section I commencing at a point in SE $\frac{1}{4}$ SE $\frac{1}{4}$ , Sec. 8, T12N, R88W, thence running in a South-easterly direction through Sections 17 & 16, T12N, R88W to a point in SW $\frac{1}{4}$ SW $\frac{1}{4}$  Sec. 16, T12N, R88W, thence Easterly through Sections 16, 15, and 14, T12N, R88W to a point on the Wyoming-Colorado State Line, in SE $\frac{1}{4}$ SE $\frac{1}{4}$  Sec. 14, T12N, R88W.

Section II thence beginning at a point on the Wyoming-Colorado State Line in Sec. 13, T12N, R88W, Easterly, through Sec. 13, T12N, R88W, and Sections 18 & 17, T12N, R87W, ending at a point on the Wyoming-Colorado State Line in Sec. 17, T12N, R87W. Grading, draining, 6" crushed gravel base, and necessary fencing. A distance of approximately 4.5 miles total.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.

There being no further business, the meeting was adjourned.
