COMMISSIONERS PROCEEDINGS

SPECIAL MEETING

The Board of Commissioners met in Special Session at 2, P.M., all members present, to discuss the administration of the Memorial Hospital and the appointment of a new administrator to succeed Mr. Harry Dunham.

E. H. Hausner, President of the Hospital Board, Mrs. Kenneth P. Day, G. M. Allen and C. M. Stamp were present, E. R. Reynders was absent.

The County Commissioners suggested the name of I. R. Daugherty as hospital administrator. Mr. Hausner of the Hospital Board advised that they would consider Mr. Daugherty along with other applications for this position which should be an experienced person. No agreement was reached with this plan and the Commissioners again recommended Mr. Daugherty for immediate appointment. Members of the Hospital Board reminded the Commissioners that they had been appointed to this Board and that they should have some authority in selection of an administrator, and if they had to accede to the selection of the Commissioners, no Hospital Board would be necessary. Mr. Hausner then resigned and the resignation was accepted and the Commissioners disbanded the Hospital Board.

Mr. Daugherty was appointed as Hospital administrator. No new appointments were made for a new Hospital Board.

CERTIFICATE OF PURCHASE NO 4075 was assigned to Eugene or Thelma Jean Pettigrew for the sum of \$109.50. There being no further business the meeting was adjourned.
