## TAX LEVY MEETING

The Board of Commissioners met August 5, 1963, at 3:00 P. M., all members present, together with the County Assessor, R. A. Hakala, for the purpose of fixing the Tax levies for and within Carbon County for the year 1963-1964 in compliance with Chapter 39-89 Wyoming Statutes, 1957.

Having received from the State Board of Equalization notice that the assessed valuation of Carbon County for the year 1963-1964 has been found to be \$50,721,598.00, the County Assessor advised the Board of the assessed valuation of each of the various municipalities and school districts with the County, and the Board proceeded to fix the levies upon the assessed property of Carbon County for the year 1963-1964 as follows:
