NOTICE OF LOCATION OF PUBLIC ROAD

TO WHOM IT MAY CONCERN:

The Board of County Commissioners of Carbon County, Wyo. have decided to locate a road to be known as WILLFORD COUNTY ROAD NO. 604, commencing at a point on the line between sections 31 & 6, T. 16 N., R. 84 W., & T. 15 N., R. 84 W. which is east 531.06' from the NW corner section 6, T. 15 N., R. 84 W.; and traverses easterly along said township line through sections 32 and 5 to a point on said township line between sections 33 and 4 T. 16 N., R. 84 W. and T. 15 N., R. 84 W. respectively, which is west 1760.85' from the NE corner of sec 4, T. 15 N., R. 84 W.; thence said road traverses north-easterly through sections 33, 34, 35, and 36, T. 16 N., R. 84 W. terminating at a point of intersection with the Cow Creek county road in section 36 T. 16 N., R. 84 W. The right of way shall be one hundred (100) feet in width being fifty (50) feet right and fifty (50) feet left of the following described centerline. Said road to be approximately 5.88 miles in length.

The proposed location and width of right of way required are set forth in detail on a map on file with the County Clerk and may be examined at his office.

Any land owner or interested party desiring to raise any question with respect to the necessity of the taking of the land for road purposes shall do so by filing, within thirty days after the last publication of this notice, a petition in the District Court of the county in which the land is located. If no petition to raise the question of necessity is filed within the said thirty day period, the necessity shall be presumed and the question cannot later be raised.

All other objections thereto or claims for damages by reason thereof must be filed in writing with the County Clerk of said county before noon on the 6th day of November, A. D., 1963, or such road will be established without reference to such objections or claims for damages..
