OLD SARATOGA-ENCAMPMENT STATE HIGHWAY NO. 230: A hearing was held regarding proposed abandonment of a section of the old highway between Saratoga and Encampment at a point about 9 miles south of Saratoga. A petition was received by the Board recommending the retention of this portion of the highway for the benefit of truckers hauling logs, and several letters were received in favor of the abandonment of this portion of the old road.

It was decided that the office of the Attorney General should investigate the present ownership before any further action could be taken.

CHARLES W. JEFFREY COMMUNITY CENTER: The Board met with Dr. Jeffrey, architect Davis and attorney Oscar Hall to review the plans and specifications for the Community Center. The plans and specifications were approved by the Board. A call for Bids will be advertised in a short time.

HOG PARK ROAD: A letter was received from W. E. Mugsbach, forest supervisor in Laramie, Wyo. advising that he would attend the Commissioners Meeting on March 5, 1963 to discuss a proposed road from Encampment to Hog Park.
