A Notice of Hearing on the proposed transfer of funds from the Cash Reserve Fund was advertised March 18, 1964 as follows: County Clerk \$1500.00, Coroner \$75.00, Court House & Jail \$1300.00, Water Commissioner \$1000.00, County Attorney \$500.00, Clerk of Court \$5,500.00, Road & Bridge \$20,000.00.

IT IS HEREBY RESOLVED that the County Budget Officer and County Treasurer be authorized to transfer the above mentioned funds.

SPRING CREEK COUNTY ROAD NO. 385: A motion was made by Orton, seconded by Niland and carried whereby the following resolution was adopted, to wit:

R E S O L U T I O N

WHEREAS, The Board of County Commissioners have decided to locate a road to be known as Spring Creek County Road No. 385, and

WHEREAS, the Notice of Location containing the description of the proposed road was published in the Rawlins Daily Times on March 12, 19, 26, 1964, and

WHEREAS, no claims have been filed within the time shown on the Notice of Location, and the necessary easements have been signed by Betty Davis Galyon,

NOW, THEREFORE BE IT RESOLVED, That the road as described above and shown in detail on the map on file with the County Clerk, be and is hereby declared established.

SARATOGA - TEN MILE ROAD NO. 504. The Commissioners decided to postpone action on the above road until May 5, 1964 pending a meeting with the owners of the land.

CHANGE OF NAME - WYOMING ROAD 130 TO READ WYOMING ROAD 230. The Commissioners accepted the following resolution from the minutes of the Wyoming Highway Commission dated May 23, 1963.

R E S O L U T I O N

WHEREAS, a certain portion of FAP Route 22-1 (Wyoming 230) located in Carbon County, Wyoming, as previously located and traveled is no longer needed for State highway purposes:

NOW THEREFORE; BE IT RESOLVED; that the following described existing right of way be removed from the State Highway System and be conveyed to the Board of County Commissioners of Carbon County, Wyoming, with the full responsibility of maintenance, control and supervision.

Commencing at a point on the south right-of-way boundary of the presently existing Ryan Park-Wyoming No. 130 road, Project S-0103 (2), situated in the $SE\frac{1}{4}$ of the $NW\frac{1}{4}$ of Section 16, T. 16N., R. 83 W., of the 6th P.M., Wyoming thence running southeasterly through Sections 16 and 21, T. 16N., R. 83 W., to a point on the east right-of-way line of F-022-1 (4) in the $NE\frac{1}{4}$ of the $SE\frac{1}{4}$ of Section 29, T. 16N., R. 83 W., of the 6th P. M., Wyoming a distance of 13,590 feet, (2.574 miles) more or less.

Part of old FAP 174 A included in this action.

HUNT ADDITION TO THE TOWN OF BAGGS: The Board signed and accepted the dedication and plat of the Hunt Addition to the Town of Baggs.

There being no further business the meeting was adjourned.
