## REGULAR MEETING

The following was omitted from the minutes of Commissioners Meeting held June 1, 1965.

LIMITED RETAIL DISPENSING ROOM HOURS: EXCEPTION FOR SUNDAY, ANNUAL FOUR DAY PERIOD

CHAPTER 21: Original House Bill No. 79 - Hours of Liquor Sale

A meeting was held with representatives of the Rawlins, Paratoga, Encampment, Snake River, and McFadden liquor dealers, relative to unrestricted operation of liquor dispensing bodies of Carbon County.

A motion was made, seconded and carried, whereby the following dates were chosen for the operation of liquor dispensing establishments: June 6, June 20, July 4 and September 5, 1965.

It is understood and agreed that the liquor dispensing establishments will be allowed to open at 6 A. M. on each of the above Sundays and close, in compliance with the City or Town Ordinances.
