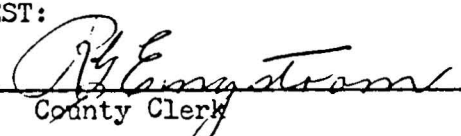
The Board of Commissioners met at 2:00 P. M. , all members present, John Orton, Chairman.

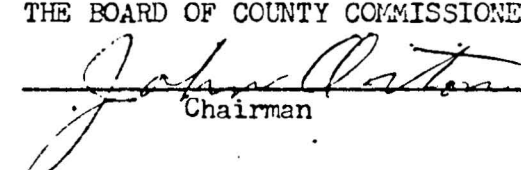
