HOLMES - FRENCH ROAD CARBON COUNTY ROAD NO. 660. The Board of Commissioners received a claim for damages on December 8, 1965 in the amount of \$59,617.50 from Charles A. Sanger, Kathryn L. Sanger, Millicent Sanger & Sanger Ranches, Inc. in compliance with the Notice of Location of Public Road published in the Rawlins Daily Times on October 21, 28 and November 4, 1965 and the Claim for damages was received in writing by the County Clerk on or before noon on the 8th day of December, 1965.

The Board of Commissioners appointed I. A. "Bus" Rendle, Rawlins, Francis Ravencroft, Saratoga and John Runner, Saratoga as appraisers and instructed them to make a report of their findings to the Board of County Commissioners on January 5, 1966. This Board was unable to meet and notified the County Commissioners.

A new Board of appraisers was appointed and instructed to meet on February 16, 1966 together with Allen W. Mace, County Surveyor and to render the appraisers report to the Board of Commissioners on March 2, 1966. ~~The date of the meeting of the appraisers and surveyor to be held on February 16, 1966.~~ The new board being, Francis Ravencroft, Saratoga, Robert Johnson, Elk Mountain, and Bruce Nixon, Saratoga.

There being no further business the meeting was adjourned.

There were also present Road Appraisers Bruce Nixon, Francis Ravenscroft and Robert Johnson who acted as the Board of Appraisers on the Holmes - French (Sanger) Road. Attorney J. R. Smyth, Mrs. Millicent Sanger and Charles Sanger met with the Commissioners, also County Surveyor, Allen W. Mace.

The Board of Appraisers were instructed to report to the Board of Commissioners on March 2, 1966, however, they had completed their appraisal on February 16, 1966 and submitted the report as follows of their findings.

"We, on the 16th day of February A. D. 1966, proceeded and viewed said proposed road the whole distance thereof through said premises of said claimant, and thereupon we have assessed and determined that said premises will be rendered less valuable in the sum of \$50.00 per acre by the said establishment of said road and that said complainant will thereby sustain damages in the sum of \$50.00 per acre for a total damage to Sanger Ranches, Inc. of \$1923.50 - Total acres 38.47."
