## SHIRLEY RIDGE ROAD:

A motion was made by Salisbury, seconded by Niland and carried whereby the following resolution was adopted relative to SHIRLEY RIDGE ROAD.

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of the County of Carbon, is desirous of taking advantage of the provisions of Section 24-38, U. S. 1957, and/or Chapter 118, Session Laws of Wyoming, 1951, by cooperating with the State Highway Commission of Wyoming in the improvement of a county road, the location and extent of which is as follows:

1. Beginning at a point on FAS Route 0405 in Section 3, T.27 N., R. 80 W. thence northeasterly and southeasterly to Shirley Basin in Section 28, T. 28 N., R. 78 W., of the 6th P.M., Wyoming.
2. Realignment of curves and shoulder alignment.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering said improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said county; that the chairman of said Board and the County Clerk of said county be, and they are hereby authorized and directed to execute said contract on behalf of said Board.
