A regular meeting of the Board of County Commissioners (herein sometimes designated as the "Board") of the County of Carbon, State of Wyoming, was held at the regular meeting place of the Board at the County Courthouse, in Rawlins, Wyoming, in said County, on Tuesday, the 7 day of November, 1967, at the hour of 10:00 o'clock a.m., pursuant to notice and call duly given to each member of the Board.

Thereupon, Commissioner John Orton introduced the following resolution, which was thereupon read in full and is as follows:

R E S O L U T I O N

WHEREAS, the County of Carbon (herein sometimes designated as the "County"), in the State of Wyoming, is a county duly organized and existing as such under the Constitution and laws of the State of Wyoming; and

WHEREAS, the Board of County Commissioners of the County (herein sometimes designated as the "Board"), has determined, and does hereby determine, that it is necessary and for the best interests of the County and its inhabitants that a new county hospital be constructed and equipped; and

WHEREAS, there are not sufficient funds in the treasury of the County available for that purpose; and

WHEREAS, the Board deems it necessary and advisable that a bonded indebtedness be contracted in the aggregate principal amount of not to exceed \$1,000,000.00 for the purpose of providing means for the construction and equipment of a new county hospital; and

WHEREAS, the laws of the State of Wyoming empower the Board, whenever a majority thereof so decide, to submit to the electors of the County the question of whether the Board shall be authorized to issue the registered coupon bonds of the County for said purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING:

Section 1. Ratification. That all action heretofore taken (Not inconsistent with the provisions of this resolution) by the Board and the officers of the County, directed toward constructing and equipping a new county hospital, and the issuance of its registered coupon bonds for said purpose be, and the same hereby is, ratified, approved and confirmed, including without limiting the generality of the foregoing, authorizing the issuance of the bonds at an election and giving notice thereof.

Section 2. Bond Election. That a special bond election in and for the County be, and the same hereby is, directed to be held on Tuesday, the 5 day of December, 1967, between the hours of 9:00 o'clock a.m. and 7:00 o'clock p.m., at which election there shall be submitted to the qualified electors of the County the question set forth in the form of proclamation and notice of election provided by Section 8 of this resolution.

Section 3. Ballots. That the printed ballots to be used at said election shall be prepared and furnished by the County Clerk to the judges and clerks of such election to be by them furnished to the electors. Said ballots shall be printed on white paper and colored paper as hereinafter provided and shall be substantially the following form:

All being qualified electors of the County and shall constitute the Boards of Election for said precincts. Said persons are hereby appointed for the respective positions above named; and they shall be administered an oath in substantially the following form:

" I do solemnly swear (or Affirm) that I will impartially and to the best of my knowledge and ability, perform the duties of (Judge or Clerk, as the case may be) of this election, and I will studiously endeavor to prevent all frauds, deceit and abuse in conducting the same."

Section 7. Publication of Proclamation and Notice of Election. That a proclamation and notice of election shall be made and given in substantially the same form as provided in Section 8 hereof, by publication in the following manner:

A. One publication in the Rawlins Daily Times, which is published in and is the official newspaper of the County, not sooner than twenty-five (25) days nor less than fifteen (15) days before the election.

B. Two additional publications in each newspaper published in the County, the first publication being at least ten (10) days before the election, and the second publication being upon the last day upon which such newspaper is published before said election.

Section 8. Form of Proclamation and Notice of Election. The voting qualifications for said bond election shall be as designated in the following proclamation and notice, which shall be signed by the Chairman of the Board and attested by the County Clerk, and be in substantially the following form:

QUESTION SUBMITTED

Shall the Board of County Commissioners of Carbon County, Wyoming, be authorized to issue the registered coupon bonds of said County, in an amount not to exceed \$1,000,000.00, or so much thereof as may be necessary, for the purpose of providing means for the construction and equipment of a new county hospital, to bear interest at a rate or rates not to exceed six per centum (6%) per annum, and to be issued and sold upon such lawful terms and conditions, and with such covenants and agreements as the Board may determine, including, at its option, provisions for the redemption of bonds prior to the maturity without or with the payment of a premium?

For the purpose of said special bond election only, the election districts, voting precincts and polling places heretofore established by the County Commissioners and utilized at the general election held in said County on the 8th day of November, 1966, shall be utilized for said special election and said polling places are as follows:

Every citizen of the United States of the age of twenty-one years and upwards who has resided in the State one year and in the County of Carbon sixty days and in the election precinct wherein he seeks to vote for ten days next preceding such election, and who has complied with the registration laws of the State of Wyoming, shall be entitled to vote on such question, provided that he appears in person at the polls on the day of election.

The official ballot, after the statement of the question, shall contain the words "For Hospital Bonds." and the words "Against Hospital Bonds." The voter shall prepare his or her ballot on said proposal by marking a cross in the square immediately to the right of the group of words which expresses his or her choice on the question submitted.

At said election two ballot boxes shall be provided at each of the polling places, one to be designated Ballot Box "A" and the other to be designated Ballot Box "B". There shall also be provided two sets of bond ballots, one of which shall be printed on white paper and the other on colored paper, both of which shall contain the same statement of the proposal to be voted upon and the same instructions regarding the manner of marking the same. If the elector desiring to vote is not the owner of, or the spouse of the owner of, real or personal property assessed on the assessment roll of said County, he shall be furnished by the officers conducting such election, a ballot printed on white paper, and the ballots of all such persons shall be deposited in Ballot Box "A." If such elector is the owner of, or the spouse of the owner of, real or personal property assessed on the assessment roll of said County, he shall be furnished by such officers a ballot printed on colored paper, and the ballots of all such persons shall be deposited in Ballot Box "B." Before any person shall be permitted to vote a ballot printed on colored paper, he or she shall be required to make, before the officers of election, an affidavit showing that he is the owner of, or the spouse of the owner of, real or personal property assessed on the assessment roll of said County.

Section 9. Registration. That all persons whose registration for voting is in force in accordance with the laws of this State and whose name appears on the County's "official register of voters" registry list shall be entitled to vote at said election on said bond question without registration. Not less than fifteen days before the special bond election herein provided, any elector residing in and entitled to vote in any election district of this County whose name does not appear on the official register of voters, may register as follows:

a. Appear in person before a deputy or clerk in the office of the clerk in the city or town of his residence, or of the County Clerk, and apply to have his or her name entered upon the registry list of electors in such district. Provided that upon receiving from such applicant the "Oath of Applicant to Register," prescribed by Section 22-158, Wyoming Statutes 1957, and provided the applicant meets the general qualifications required of voters in this state, the registry agent (if he be the County Clerk) shall forthwith enter the name of such applicant upon the proper registry list. If said registry agent be a city clerk or town clerk, he shall forthwith transmit the applicant's oath to the County Clerk who shall forthwith enter the name of the applicant upon the registry list, provided the applicant meets the general qualifications required of voters in this State.

b. Not less than thirty (30) days before said special election, if an elector shall be absent from his place of residence or unable because of physical disability or infirmity to appear and register as above provided, such elector may apply to the County Clerk for the oath above mentioned, and immediately upon receipt of the same, said County Clerk shall mail to said applicant, said oath, which said applicant shall complete, and subscribe to before some person entitled to administer oath and return said oath to said County Clerk in order to be received by him not less than fifteen (15) days before an election, said clerk shall register said elector as in the case of qualified registrants provided for above.

Section 10. Non-Property Owners. That is such elector on said bond question is not the owner of, or the spouse of the owner of, real or personal property assessed on the last assessment roll of the County, he shall be furnished by the officers conducting the election a ballot printed on white paper, and the ballots of all such persons shall be deposited in Ballot Box "A."

Section 11. Property Owners. That is such elector on said bond question is the owner of, or the spouse of the owner of, real or personal property assessed on the last assessment roll of the County, he shall be furnished by such officers a ballot printed on colored paper, and the ballots of all such persons shall be deposited in Ballot Box "B."

Section 12. Form of Property Owner's Affidavit. That before any person shall be permitted to vote a ballot printed on colored paper, he shall be required to make, before the officers of election who are hereby authorized to take the same, an affidavit showing that he is the owner of, or the spouse of the owner of, real or personal property assessed on said assessment roll, in substantially the following form:

Section 13. Polling Hours and Canvass by Election Board. That the polls shall be open on said election day, at 9:00 o'clock a.m. and shall remain open until and shall close at 7:00 o'clock p.m. of said day, and that immediately after the closing of the polls the election officers in each precinct shall proceed to canvass the ballots in Ballot Box "A", and, at the conclusion of such canvass, shall then proceed to canvass the ballots in Ballot Box "B." Separate and distinct records shall be made of the canvass of each box, and the results disclosed by such canvass shall be made out, certified and returned under seal by the election officers to the Board of County Commissioners.

Section 14. County Canvass Board. That on the fifteenth day after the close of said election, or sooner if all returns be received, the County Clerk and two Justice of the Peace of the County shall examine and canvass the returns and declare the results of the bond election.


Section 15. Authorization. That the officers of the County be, and they hereby are authorized and directed to take all action necessary or appropriate to effectuate the provisions of this resolution.

Section 16. Repealer. That all by-laws, resolutions, and parts of resolutions in conflict with this resolution are hereby repealed.

Section 17. Severability. That if any section, papagraph, clause or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, papagraph, clause or provision shall not affect any of the remaining provisions of this resolution.


