The Board resumed its session, all members present.

ABANDONMENT OF PUBLIC ROAD: On December 9, 1966 a Notice of Abandonment of Public Road was published in the Daily Times and described as a portion of the old W. H. D. Highway No. 130-230 in portions of Sections 5, 8, 9 and 16, Township 16 N, Range 83 W of the 6th P.M. The date of hearing of protests was set for February 8, 1967.

Several protests were received by the Board and action on this proposed abandonment was postponed.

CERTIFICATE OF PURCHASE No. 4260 was assigned to G. L. Campbell on Lots 3 and 4 Block 8, Franklin Addition to Baggs for the sum of \$253.09.

LIMITED LIQUOR LICENSE: There being no protests entered, Limited Liquor license No.129 was granted to Stage Coach Inn, 14 miles north of Rawlins to Fred O. Leonard, Ray and Lavina Wagner, partners for the sum of \$100.00.

BIDS ON SHERIFF'S CAR: Bids on Sheriff's car were received from Lefforge Motor, McMahon Motors, McGee-Murphy and Leiber Motor Co. The Board reviewed the bids and awarded the bid to Leiber Motor Company.

A motion was made by Orton, Seconded by Salisbury and carried whereby the following resolution was adopted.

A RESOLUTION AUTHORIZING THE COUNTY AND
PROSECUTING ATTORNEY OF CARBON COUNTY,
WYOMING, TO PARTICIPATE IN THE WYOMING
DEFENDER AID PROGRAM

WHEREAS the Wyoming Defender Aid Program is a project sponsored by the University of Wyoming College of Law and the Wyoming State Bar whereby a prosecuting attorney may request and obtain, without cost or charge, assistance in research and investigative assistance from the University of Wyoming College of Law.

WHEREAS this program would be of benefit to Carbon County and its citizens and the county should participate in the program.

BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS
OF CARBON COUNTY, STATE OF WYOMING:

That said Carbon County shall participate in the Wyoming Defender Aid Program, without cost or obligation to the County, and the County and Prosecuting Attorney is hereby authorized to cooperate with and participate in said program.

Passed and approved this 8th day of February, 1967.

COUNTY FAIR BOARD: The Board reappointed Eugene Breniman to the Carbon County Fair Board for a five year period, commencing 2-2-67 to 2-2-72.

FAS ROUTE 0401-RIVERSIDE: The Board entered into an agreement with the Wyoming Highway department that certain preliminary engineering be done necessary for contemplated construction of a secondary road located in said county, being described as:

FAS Route 0401:

From FAP route 22-1 at Riverside, southwesterly for approximately 10 miles and from the end of S 0401 (3) 2 northeasterly for approximately 10 miles.

ABATEMENT: Ruben Borrego, Hanna, double payment of poll tax \$2.00.

There being no further business the meeting was adjourned.
