VACATION OF JACKSON COUNTY ROAD NO. 6322

A petition requesting abandonment of the above road was received by the Board, this petition was signed by more than 10 residents of Carbon County residing within 40 miles of the proposed vacation and abandonment. A motion was made by Orton seconded by Niland and carried whereby the following resolution was adopted to wit:

RESOLUTION

WHEREAS, ten or more electors of Carbon County, Wyoming residing within 40 miles of the Jackson County Road No. 6322, having filed a petition for the vacation of a portion of said road described as follows:

Commencing at a point on the east line of Sec. 2, T. 17N., R. 84 W. 6th P.M., Carbon County, Wyoming, that is 1172.52 feet south of the NE corner of said Sec. 2; thence S78°25' west 749.73 feet; thence north 61°58' west 511.35 feet; thence north 45°22' west 177.48 feet; thence south 26°52' west 49.42 feet to the west line of Lot 1 of said Sec. 2.

NOW THEREFORE, it is resolved that Reino Hakala, a suitable and disinterested elector of Carbon County, Wyoming is hereby appointed as a viewer, and after having been sworn according to law shall examine into the expediency of the proposed vacation of the above described portion of said county road and to report in writing immediately to this Board.

REPORT OF VIEWER was received from Reino Hakala stating "that in my judgement that portion of the above described county road is not practicable and ought to be vacated and abandoned." A motion was made by Orton, seconded by Niland and carried whereby the following resolution was adopted:

RESOLUTION DETERMINING TO  
VACATE COUNTY ROAD

WHEREAS, ten or more electors of Carbon County, Wyoming residing within 40 miles thereof have petitioned the Board of the County Commissioners of Carbon County, Wyoming to vacate and abandon a portion of the Jackson County Road No. 6322, and

WHEREAS, pursuant thereto Reino Hakala was appointed on July 2, 1968 to examine into the expediency of the proposed vacation of said road and to report in writing immediately to this Board, and

WHEREAS, said Reino Hakala as a viewer has taken and filed his oath with the County Clerk as required by law and has this day reported in writing to this Board recommending that the road as described in said Petition should be vacated and abandoned for the reasons set forth in such written report, which is made a part hereof.

NOW THEREFORE, be it resolved that the Board of County Commissioners of Carbon County, Wyoming do hereby determine to vacate and abandon that part of the Jackson County Road No. 6322 described as follows:

COMMENCING AT A POINT ON THE EAST LINE OF S

Road

July 2, 1968

Commencing at a point on the east line of Sec. 2, T. 17 N., R. 84 W. 6th P. M., Carbon County, Wyoming, that is 1172.52 feet south of the NE corner of said Sec. 2; thence S 78°25' west 749.73 feet; thence north 61°58' west 511.35 feet; thence north 45°22' west 177.48 feet; thence south 26°52' west 49.42 feet to the west line of Lot 1 of said Sec. 2.

BE IT FURTHER RESOLVED, that all objections to the vacation and abandonment of said portion of said road and claims for damages by reason thereof, shall be filed in the office of the County Clerk of Carbon County, Wyoming on or before noon of August 6, 1968, and that notice of such vacation and abandonment shall be published for three successive weeks in some official newspaper published in the county, mailed by registered mail to all persons owning lands or claiming an interest in any lands over or across which said road is proposed to be vacated and abandoned.

PARI-MUTUEL WAGERING: A motion was made by Orton, seconded by Niland and carried whereby the following resolution was adopted to-wit:

RESOLUTION

BE IT RESOLVED that the following question be submitted to the voters of Carbon County at the primary election to be held on August 20, 1968;

"Should race meets with pari-mutuel wagering, pursuant to Chapter 245, Session Law of Wyoming, 1967, be held in Carbon County in the year 1968 and in subsequent years thereafter?"

BE IT FURTHER RESOLVED that the County Clerk be directed to prepare the appropriate ballots and publish notice of such proposition being placed on the ballot in the manner required by law.

Thereupon the Board adjourned until the following day.

July 3, 1968 The Board resumed its session, all members present.

NOTICE OF VACATION OF PUBLIC ROAD

TO ALL TO WHOM IT MAY CONCERN:

The Board of County Commissioners of the County of Carbon, State of Wyoming has decided to vacate that part of the Jackson County Road No. 6322 commencing at a point on the west line of Sec. 2, T. 17 N., R. 84 W. 6th P.M., Carbon County, Wyoming, that is 1172.52 feet south of the NE corner of said Sec. 2; thence S 78°25' west 749.73 feet; thence north 61°58' west 511.35 feet; thence north 45°22' west 177.48 feet; thence south 26°52' west 49.42 feet to the west line of Lot 1 of said Sec. 2.

The reason for the proposed vacation and abandonment is that the above described portion of said road is no longer used by the general public and no injury will result to adjoining land owners.

All objections, threats, or claims for damages by reason thereof must be filed in writing with the County Clerk of said county, before noon on the 5th day of August, 1968, or said portion of said road will be vacated and abandoned without reference to such objections or claims for damages.



APPROPRIATION RESOLUTION

WHEREAS, on the 10th day of June, 1968 GENERAL FUND:

R. G. Engstrom, County Clerk the budget making authority, prepared and submitted to the Board a county budget for the 1968 - 1969 fiscal year ending June 30, 1969,

WHEREAS, such a budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Rawlins Daily Times a legal newspaper published and of general circulation in the county on the 16th day of July, 1968 and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in such proposed budget, all of which more fully appear in the minutes of this Board.
