COMMISSIONERS PROCEEDINGS
SPECIAL MEETING

The Board of Commissioners met at 2:00 P. M. , Niland and Salisbury present, Orton absent.
G. T. Bath, Engineer from the Wyoming Highway Department met with the Board and the following agreement was entered into.

THIS AGREEMENT, made and entered into as of the 20th day of August, A. D. , 1968 between the WYOMING HIGHWAY DEPARTMENT, hereinafter referred to as the "Department" and the COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING, hereinafter referred to as the "County".

WITNESSETH:

WHEREAS, the County has filed with the Department their request that certain preliminary engineering be done necessary for contemplated construction of a secondary road located in said county, being described as: FASRT.0409. From a point as FAS Route 0405 Approximately 22 Miles north of Medicine Bow, northeasterly for approximately 12 miles to a county road junction south of Shirley Basin.

WHEREAS, the Department is willing to do such preliminary engineering if the cost of such engineering is borne by the Bureau of Public Roads as provided by the Federal Aid Road Act, July 11, 1961 (39Stat. 335) as amended and supplemented thereto.

NOW THEREFORE, in consideration of the premises and the mutual covenants of the parties hereto, it is agreed as follows;

1. That the Commission will perform or cause to be performed under its direct supervision all preliminary engineering work contemplated and provided for herein and shall provide for associated construction in a subsequent program.
2. The County agrees to reimburse the Department one hundred per cent (100%) of all sums expended by said Department in furtherance of this Agreement if the actual construction is abandoned or is not begun within a reasonable period of time, as determined by the normal sequence of the Department's construction period.

VACATION OF PUBLIC ROAD- JACKSON COUNTY ROAD NO. 6322

A motion was made by Salisbury and seconded by Niland whereby the following resolution was adopted, to wit:

RESOLUTION

WHEREAS, The Board of County Commissioners have decided to abandon the Jackson County Road No. 6322, and
WHEREAS, The Commissioners proposed the abandonment of the above mentioned road for the reason that said road is no longer in use by the general public and,
WHEREAS, A Notice of Vacation of Public Road was published in the Rawlins Daily Times on July 6, 13, and 20, 1968, this notice stipulated that all objections and claims for damages must be filed in writing with the County Clerk of said County, before noon on August 5, 1968, or such road will be abandoned without reference to such objections or claims for damages, and
WHEREAS, The County Clerk sent registered letters to the land owners in the vicinity of this road abandonment, and
WHEREAS, no protests were received to this abandonment,
NO THEREFORE BE IT RESOLVED, that the Board of County Commissioners declare ~~that~~ Jackson County Road No. 6322 abandoned.

There being no further business, the meeting was adjourned.
