R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, deem that a portion of old State Project 1787, described as follows:

Beginning at a point on the southerly boundary of the new right of way for existing Project S-0105 (6), as said right of way is described in Parcel No. 1 on a Warranty Deed dated August 28, 1964 and recorded September 30, 1964 on Page 392 of Book 459 in Carbon County;

thence southerly and easterly a distance of 0.823 miles, more or less, across Lot 2 and Lot 1 of Section 6 and across Lot 4 and Lot 3 of Section 5, T. 19 N., R. 77 W. of the 6th P.M., Carbon County, Wyoming, to a point on the west boundary of said Carbon County, which point of ending is located on the east boundary of said Lot 3, from which the north quarter corner of said Section 5 bears northerly 821.0 feet,

being no longer used or necessary for State Highway purposes, would, in the best interest of the public, be a necessary and desirable extension of the Carbon County Road System.

NOW, THEREFORE BE IT RESOLVED, that the said Board do hereby declare that Carbon County will assume all responsibility with regard to repair, service and maintenance of the above described portion of old State Project 1787 upon relinquishment by the State Highway Commission of Wyoming to Carbon County.

A regular meeting of the Board of County Commissioners (herein sometimes designated as the "Board") of the County of Carbon, State of Wyoming, was held at the regular meeting place of the Board in the Commissioners' Room in the Carbon County Courthouse in Rawlins, Wyoming, in said County, on Tuesday, the 5th day of March, 1968, at the hour of 10 o'clock a. m., pursuant to notice and call duly given to each member of the Board.

The meeting was called to order by the Chairman of the Board, and upon roll call the following members were found to be present, constituting a quorum:

The following proceedings, among others, were had and taken:

Thereupon, Commissioner John Orton introduced the following resolution, which was thereupon read in full and is as follows:

R E S O L U T I O N

WHEREAS, the County of Carbon (herein "County"), in the State of Wyoming, is a county duly organized and existing as such under the Constitution and laws of the State of Wyoming; and

WHEREAS, the Board of County Commissioners of the County (herein sometimes designated as the "Board"), has determined, and does hereby determine, that it is necessary and for the best interests of the County and its inhabitants that a new county hospital be constructed and equipped; and

WHEREAS, there are not sufficient funds in the treasury of the County available for that purpose; and

WHEREAS, at a bond election of the qualified electors of the County held therein on the 5th day of December, 1967, the Board was authorized to issue the registered coupon bonds of said County, in an amount not to exceed \$1,000,000.00, or so much thereof as may be necessary, for the purpose of providing means for the construction and equipment of a new county hospital, said bonds to bear interest at a rate or rates not to exceed six per centum (6%) per annum, and to be issued and sold upon such lawful terms and conditions, and with such covenants and agreements as the Board may determine, including, at its option, provisions for the redemption of bonds prior to maturity without or with the payment of a premium; and

WHEREAS, the laws of the State of Wyoming require that such bonds be sold after public advertisement.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, STATE OF WYOMING;

Section 1. Determination to Advertise Bonds. That the "Carbon County, Wyoming, General Obligation Hospital Building Bonds, Series May 1, 1968," in the aggregate principal amount of \$1,000,000.00, of the County of Carbon in the State of Wyoming, be advertised for sale immediately by the County Clerk.

Section 2. Publication of Notice of Sale. That the notice of sale shall be published at least once a week for two consecutive weeks in the Rawlins Daily Times, a newspaper of general circulation published in the County and in a newspaper of general circulation

published in Cheyenne, Wyoming, the first publication in each newspaper to be at least two weeks prior to the date of sale.

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Carbon County, Wyoming, on Tuesday, March 26, 1968, at the hour of 10:00 o'clock a.m., M.S.T., in the Commissioners' Room in the Carbon County Courthouse in Rawlins, Wyoming, will receive sealed bids and publicly open the same for the purchase of the negotiable, coupon Carbon County, Wyoming, General Obligation Hospital Building Bonds, Series May 1, 1968" (herein "bonds"), in the aggregate principal amount of \$1,000,000.00. The Bonds will be dated May 1, 1968, payable to bearer, in the denomination of \$1,000.00 each, and bear interest at a rate or rates of not exceeding 5- $\frac{1}{2}$ % per annum, evidenced until maturity by only one set of interest coupons (supplemental interest coupons, i.e., "B" coupons, are not permitted), payable on May 1, 1969, and semiannually thereafter. Subject to the aforesaid limitations, it is permissible to bid different or "split" interest rates for said bonds, without limitation as to the number of rates specified, provided that one interest rate only shall be stated for any maturity. Each rate specified and to be evidenced by any coupon must be in a multiple of one-eighth ($\frac{1}{8}$) or one-twentieth ($\frac{1}{20}$) of one per centum (1%) per annum. Both principal and interest shall be payable at the office of the County Treasurer of Carbon County, Rawlins, Wyoming.

Said bonds shall mature serially in regular numerical order on the first day of May in the amount of \$50,000.00 in each of the years 1969 through 1988. Bonds maturing on and after May 1, 1979, shall be subject to prior redemption in inverse numerical order, at the option of the County, on May 1, 1978, or on any interest payment date thereafter, at a price equal to the principal amount of each bond so redeemed, accrued interest, and a premium of 2% for the first 12 call dates and 1% if redeemed thereafter prior to maturity. The maximum interest spread is 2% per annum. Redemption shall be made upon not less than 30 days' prior notice by publication and by mail.

The bonds shall be general obligation bonds of the County, payable from general (ad valorem) taxes, without limitation as to rate or amount.

Any bidder is required to submit an unconditional bid specifying the lowest rate or rates of interest and any premium at which the bidder will purchase the bonds at or above par. Each proposal must be in writing for all of the bonds and enclosed in a sealed envelope marked on the outside "Proposal for Bonds," and addressed to R. G. Engstrom, County Clerk, Carbon County Courthouse, Rawlins, Wyoming 82301. Except for any bid of the State of Wyoming or any board or department thereof, each bid must be accompanied by a separate deposit of at least \$20,000.00, in the form of either cash, or a cashier's check or treasurer's check of, or a certified check drawn on, a solvent bank or trust company, payable to the County, which deposit shall be promptly returned if the bid is not accepted. None of such bonds will be sold at less than par and accrued interest to the date of delivery to the purchaser, nor will any discount or commission be allowed or paid on the sale of the bonds.

The Board reserves the right of waiving any irregularity or informality in any bid, or rejecting any or all bids, and of reoffering the bonds for sale, as provided by law. Subject to such reservations, the bonds will be sold to the highest and best responsible bidder making the best bid therefor. Unless the successful bidder is the State of Wyoming, the successful bidder or bidders will be required to make payment for and to accept delivery of said bonds at a bank or trust company in Rawlins, Wyoming, or elsewhere at the successful bidder's request and expense. Any bonds sold to the State of Wyoming shall be delivered in Cheyenne, Wyoming, and shall be subject to the approval of the Attorney General.

The legality of the bonds will be approved by Messrs. Dawson, Nagel, Sherman & Howard, Attorneys at Law, 1900 First National Bank Building, Denver, Colorado, whose opinion, together with the printed bonds and a certified transcript of the legal proceedings, will be furnished the purchaser without charge. Bond counsel's opinion will be printed on the bonds at the expense of the County. The Official Notice of Bond Sale, of which this publication is a condensation, a prospectus, and financial and other information concerning the County and said bonds may be obtained from R. G. PRIOR REDEMPTION: The bonds numbered 1 through 500, maturing on and before the first day of May, 1978, shall not be subject to prior redemption. The bonds numbered 501 through 1000, maturing on and after the first day of May, 1979, shall be subject to redemption prior to their respective maturities in inverse numerical order, at the option of the County, on the first day of May, 1978, or on any interest payment date thereafter prior to their respective maturities, upon payment of the principal amount of each bond so redeemed, accrued interest thereon to the redemption date, and a premium computed in accordance with the following schedule:

2% of the principal amount of each bond so redeemed, if redeemed on or after May 1, 1978, and on or before November 1, 1983;

1% of such principal amount, if redeemed thereafter.

INTEREST RATE: The maximum interest rate is five and one-half per centum (5½%) per annum, evidenced until maturity by only one set of coupons (supplemental interest coupons, i.e., "B" coupons are not permitted), payable on the first day of May, 1969, and semiannually thereafter on the first days of May and November in each year. SECURITY: The bonds will, in the opinion of counsel, be the direct general obligation bonds of the County, payable as to both principal and interest from general (as valorem) taxes levied against all taxable property within the County, without limitation as to rate or amount.

AUTHORIZATION: The bonds herein offered for sale constitute all the bonds authorized to be issued by the qualified electors of said County voting thereon at a special election held on Tuesday, the 5th day of December, 1967.

PURPOSE OF ISSUE: The bonds were authorized for the purpose of providing means for the construction and equipment of a new county hospital.

TERMS OF SALE

BID PROPOSALS: No specified form of bid is required. Each bid shall be unconditional and must specify (a) the lowest rate or rates of interest and premium, if any, at or above par at which the bidder will purchase such bonds. It is also requested for informational purposes only, but not required, that each bid disclose (b) the total net interest cost in dollars and cents to the County, and (c) the average net interest rate in a stated per centum. Each proposal must be in writing for all the bonds herein offered, enclosed in a sealed envelope marked on the outside "Proposal for Bonds," and addressed to R. G. Engstrom, County Clerk, Carbon County Courthouse, Rawlins, Wyoming.

BID CHECK: Each bid shall be accompanied (except any bid of the State of Wyoming or any board or department thereof, if one is received) by a cashier's check or treasurer's check of, or a certified check drawn on a solvent bank or trust company made payable to the County Treasurer in an amount equal to at least \$20,000.00, or by a cash deposit in like amount. Such check or cash deposit will be held as evidence of good faith pending the delivery of the bonds, which deposit (Check or Cash) shall be promptly returned to any such bidder if his bid be not accepted.

BIDDER'S OPTIONS: It is permissible, subject to specified limitations, for any bidder:

- (1) To bid different or "split" interest rates for said bonds (see "Interest Rate" above); and
- (2) To be relieved of the bidder's obligation to purchase the bonds herein offered due to the repeal of the exemption from federal income taxes (see "Tax Status" below).

SALE RESERVATIONS: The Board of County Commissioners reserves the right (1) to waive any irregularity or informality in any bid, (2) to reject any and all bids for the bonds, and (3) to re-offer the bonds for sale, as provided by law.

TAX STATUS: In the opinion of bond counsel, the interest on the bonds is exempt from taxation by the United States of America under present federal income tax laws. In the event that prior to the delivery of the bonds to the successful bidder for the bonds herein offered for sale, the income received by private holders from obligations of the same type and character shall be taxable by the terms of any federal income tax law hereafter enacted, the successful bidder may, at its election, be relieved of its obligations under the contract to purchase said bonds. In such case, the deposit accompanying its bids will be returned upon written request therefor being made to and received by the Board of County Commissioners prior to the delivery of the bonds.

BASIS OF AWARD: The bonds, subject to said reservations, shall be sold to the highest and best responsible bidder making the best bid therefor, which bid will be determined by deducting the amount of the premium bid, if any, from the total amount of interest which the County would be required to pay from the date of said bonds to the respective maturity dates at the coupon rate or rates specified in the bid; and the award will be made on the basis of the lowest net interest cost to the County. If there are two or more equal bids, and such equal bids are the best bids received and for not less than the principal amount of the bonds and accrued interest, the Board shall determine to which bidder the bonds should be sold.

SALE BELOW PAR, COMMISSION AND DISCOUNT PROHIBITED: None of the bonds shall be sold for less than the principal amount thereof and accrued interest to the date of delivery to the purchaser, nor shall any discount or commission be allowed or paid on the sale of said bonds.

TIME OF AWARD: The Board intends to take action awarding the bonds or rejecting all bids immediately after the expiration of the time herein prescribed for the opening of the bids. In any event it will take action awarding the bonds or rejecting all bids not later than twenty-four hours after the expiration of the time herein specified for opening bids.

MANNER AND TIME OF DELIVERY: The deposit of the best bidder will be credited to the purchaser at the time of delivery of the bonds (without accruing interest). If the successful bidder fails or neglects to complete the purchase of said bonds within ten days after the bonds are tendered by the County for delivery, the amount of this deposit shall be forfeited to the County (except as hereinafter provided), as liquidated damages for non-compliance with the bid; and in such case, or if all bids are rejected, the Board may offer the bonds for resale, as provided by law. 
