A Motion was made by Salisbury, seconded by Niland and carried whereby the following resolution was adopted:

RESOLUTION CREATING ZONING DISTRICT

A RESOLUTION RECOGNIZING THE EXISTENCE OF A PROGRAM DESIGNED TO DEVELOP AND FORMULATE A COMPREHENSIVE PLAN FOR LAND USE AND OCCUPANCY FOR CARBON COUNTY, WYOMING, RECOGNIZING THE NEED FOR THE ADOPTION OF INTERIM MEASURES TO MEET DEMANDS PRESENTLY EXISTING AND THE EXISTENCE OF STATUTORY AUTHORIZATION FOR SUCH ACTION, CREATING A ZONING DISTRICT, AND PROVIDING FOR LAND USE THEREIN WHICH WILL BE CONSONANT WITH THE PURPOSES AND EFFECT OF THE COMPREHENSIVE PROGRAM WHEN SUCH PROGRAM IS BROUGHT TO COMPLETION.

Whereas, the State of Wyoming by legislative enactment, WS 1957, Sections 18-289.1 et. seq., has authorized and empowered the Board of County Commissioners of counties within such state to establish a Planning and Zoning Commission to develop comprehensive plans for use and occupancy of lands, including unincorporated areas, within such county, and

Whereas, the Board of County Commissioners of Carbon County, Wyoming has established a Planning and Zoning Commission for that County, and has endorsed and subscribed to the formulation of a land use program for such County, and such Commission has adopted by-laws to govern its procedure, in accordance with Exhibits 1, 2 and 3 hereto attached, and

Whereas, such Commission has retained the services of a planning firm and through and in conjunction with such firm is preparing for adoption of a comprehensive plan of land use and occupancy for the entire County and such work is actively proceeding but considerable time will be required before it is finally adopted and placed in effect, and

Whereas, extensive and intensive mineral development is under way and being projected in the Shirley Basin Region of such County, and the further and continuing development of

mineral resources concerned and the capital installations and economic activity which will be made and carried forward as a part thereof are of great importance to and in the interest of both the State of Wyoming and the County of Carbon, and

Whereas, the land concerned in such development is public domain of the United States, and it is necessary to one phase of such development that title to a certain amount of such land be obtained from the United States, and such title must be obtained by the mining operator concerned before the land use program can be placed in effect, and the County of Carbon, working in conjunction with such mining operator and having determined that such land is required for commercial and industrial purposes and the orderly development of a community, wishes to obtain transfer to it of title to the necessary land as soon as the same may be accomplished, and

Whereas, for the purpose of obtaining transfer to it of title to the necessary land the County of Carbon desires to avail itself of the provisions of the Public Land Sale Act of 1964, and one of the conditions imposed by such Act is that adequate zoning regulations shall have been adopted, and

Whereas, the State of Wyoming by legislative enactment, WS 1957, Sec. 18-281 et seq., empowered and authorized the Board of County Commissioners of counties within the state to zone all or any part of unincorporated territory within its limits, to establish zoning districts, and to hold elections within such district so established, and, when the proposed zoning district did not include any residents, to establish such district of its own motion, and

Whereas, the zoning district hereafter created does not include any residents; and

Whereas, the nature and extent of the mining and milling work being carried on in the area concerned establishes beyond doubt or question that such is and will be the predominant and exclusive activity in such area, and the State of Wyoming has provided by legislative enactment that "no zoning resolution or plan shall prevent any use or occupancy reasonably necessary to the extraction or production of the mineral resources in or under any of the land subject thereto" (WS 1957, Sec. 18-289.1); and the use projected for the land concerned is the extraction and processing and concentration of the mineral resources and activities reasonably necessary in connection therewith, and

Whereas, the land use provided for herein is in accord with the current policies expressed by the Carbon County Planning and Zoning Commission regarding the comprehensive land use program presently being formulated for the entire County, as is shown by the expression of approval of the Planning and Zoning Commission of Carbon County, Wyoming, set forth at the end hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:·

1. Pursuant to authority granted by the State of Wyoming in WS 1957, Sec. 18-281 et seq., and, specifically, Sec. 18-284, there is hereby created a zoning district comprised of and including and limited to the following lands:

All of Sections 32 and 33, Township 28 North, Range 78 West; all of Sections 4 and 5, the east half of the east half of Section 6, the east half of the northeast quarter of Section 7, the north half and the southeast quarter of Section 8, and all of Section 9, Township 27 North, Range 78 West; 6th P.M., Carbon County, Wyoming

2. Determination having been made that there are no residents residing within such district, necessity of an election is hereby dispensed with and such district is hereby established forthwith.

3. The Board of County Commissioners hereby finds that the measures hereinafter prescribed are in the interest of the physical development of the territory concerned and will promote the public safety, the general welfare, and the proper and orderly development of the specific territory and the County of Carbon.

4. Permitted land uses within such area shall be:

a. The mining and extraction of mineral resources contained, by open pit, strip, underground, or other methods customarily employed in the mining industry, and the movement and employment of all machinery and equipment necessary or reasonably desirable in connection therewith, and including deposit of waste and spoil produced therefrom.

b. Prospecting and exploration for and development of mineral resources by any methods customarily employed in the industry for such purposes.

c. Processing, beneficiation and concentration of any ores or minerals so produced and construction, operation and maintenance of any and all buildings, fixtures, installations or processes necessary or reasonably desirable in connection therewith, and including construction and maintenance of areas for reception and control of effluents produced as a part thereof.

d. The grazing of livestock and construction and maintenance of any improvements reasonably necessary in connection therewith.

e. Range management, agricultural development, development of forage, vegetation and revegetation and land restoration measures which may be carried on as a part of livestock or range management or mining practices, including the development of reservoirs, and irrigation practices, installations and equipment.

5. Uses accessory to such permitted uses shall be:

a. Repair and maintenance of machinery, tools and equipment used in connection with any of the permitted uses, and the construction and operation of buildings and facilities desired in connection therewith.

- b. Erection and maintenance of power and transmission lines and substations and all activities reasonably desirable in the construction and maintenance thereof.
- c. Construction and maintenance of landing strips for aircraft.
- d. Use and storage of chemicals, explosives and other similar elements used in connection with any of such activities.
- e. Construction, operation and maintenance of dormitories for operating personnel of onsite facilities only, cafeterias, recreational areas and other similar facilities used for the benefit of employees and approved for this purpose by the management of any persons, firms or organizations engaged in any of the permitted uses, and also approved by the Carbon County Board of Commissioners after review and recommendation by the County Planning and Zoning Commission.

6. Uses excluded from this district shall be all of those uses not specifically permitted as stated above, or necessary or reasonably desirable in connection therewith, or uses not related to or inconsistent with the uses above set forth. Residential uses and developments of any type other than the accessory uses permitted in Section 5-e are expressly prohibited.

7. This Resolution shall be enforceable through and under the provisions and procedures set forth in WS 1957, Sec. 18-289.

8. This Resolution shall be in force and effect from and after its passage.
