#### JEFFREY CENTER - CENTRAL VOTING PLACE

The Board of County Commissioners have decided to hold a straw vote in the Rawlins Daily Times to get the sentiment, pro and con, of Rawlins voters in dividing the City of Rawlins into two voting places, namely District 1, Precinct., Pershing School Gymnasium, Southside of Union Pacific Railroad and the north side of the railroad to vote in the two basement rooms of Jeffrey Center. The District and precinct boundaries will remain the same, the only change would be the voting place for the north side of Rawlins, the same election boards will have charge of the elections, and there will be no change in precinct committeemen and committeewomen. Such a change would avail the voters of more parking space, and would eliminate voters appearing at the wrong voting place, as there would be several clerks to direct the voters.

The Commissioners approved the Jeffrey Center as a central voting place for all Rawlins precincts north of the Union Pacific Railroad. A straw vote was taken expressing the voters preference which resulted in 139 yes votes for Jeffrey Center and 19 no votes. District No. 1, Precinct No. 1 south of the railroad will vote in the gymnasium of the Pershing school.
