MEDICINE BOW TO ARLINGTON INTERCHANGE: A group from the Medicine Bow area met with the County Commissioners this morning and urged the County take immediate steps to encourage the Wyoming Highway Department to establish a primary road from Medicine Bow to the Arlington Interchange on I-80.

Those meeting with the Commission were Fred Cronberg, Justice of the Peace, Chairman; Mack Tilley, Superintendent of Utah Mining & Construction at Shirley Basin; William Cooper; Ralph Wellman, Superintendant of Public Schools; Harry Chace; and Harold M. Johnson.

Petitions were submitted signed by over 800 people in the Laramie area, Medicine Bow, Casper, Sheridan, and Big Horn Basin, which dramatically indicated the need for the extension of the State Primary System between these points.

The Commissioners have been advised that a Public Hearing will be held in the Community Hall in McFadden, Wyoming, on December 3, 1970, at 7:30 PM, for the purpose of discussing a Route from McFadden to the Arlington Interchange, to be an extention of State Secondary Highway No. 0105, Project No. SC-CFM 6-13, Rock River Interstate Road 80.

THERE BEING no further business, the meeting was adjourned.

RESOLUTION
