The bonds will be dated April 1, 1971, will be in the denomination of \$1,000 each, numbered 1 to 335, inclusive, will bear interest to be evidenced by one set of coupons only, at a rate or rates not exceeding 6% per annum, payable on April 1, 1972, and semi-annually thereafter on the 1st day of April and the 1st day of October, each year, and will mature serially on April 1, as follows:

If the State of Wyoming is the successful bidder, the bonds will be delivered to the State Treasurer in Cheyenne, Wyoming, at no expense to the State. It is anticipated that delivery of the bonds will be made within 45 days following the date of sale.

No bids will be considered for less than par and accrued interest. All bids must be without condition or reservation and except for any bid submitted by the State of Wyoming, must be accompanied by a certified or cashier's check on a bank or trust company in the amount of 3% of the bid, payable to the Treasurer of the County. The amount of the check of the successful bidder will be held by the County as liquidated damages if the bonds are not taken up and paid for promptly in accordance with the terms of the bid.

Section 1 That the bid of The First National Bank of Rawlins and Wyoming National Bank of Casper, Wyoming, for the purchase of \$335,000 General Obligation Hospital Bonds of Carbon County, Wyoming, be and the same is hereby accepted, and the bonds are hereby awarded to said bidder.

Section 2. That the good faith deposit submitted by the successful bidder be credited to the purchaser upon delivery of the bonds.
