TRANSFER OF FUNDS FROM CASH RESERVE AND SURPLUS BUDGETS.

In compliance with Art. 3 Sec. 9-535 of Municipal Budget Act, W. S. 1957, a Notice of Hearing on the proposed transfer of funds from the cash reserve was advertised on June 9, and supplemented on June 26,1972 as follows:
