DEEP CREEK NO. 801 INDUSTRIAL ROAD I. R. 6-17

On Feb. 2, 1972 the Commissioners adopted a resolution and entered into an agreement with the State Highway Commission to improve the above mentioned road. The Board also appointed Harold M. Johnson and R. A. Hakala of Rawlins and Blake Fanning of Laramie, Wyo. to view the proposed road and report to the Commissioners.

On Feb. 10, 1972, the Viewers made a report of their findings to the Commissioners as follows:

We the undersigned, having been first duly sworn to view the proposed Deep Creek No. 801 Industrial Road beginning at the boundary of the Medicine Bow National Forest in the NE $\frac{1}{4}$ of Section 11, Township 14 North, Range 88 West, extending southeasterly approximately 10.5 miles to an intersection of the Baggs-Riverside Road in the SE $\frac{1}{4}$ of Section 3, Township 13, Range 87 West, hereby submit the following report:

HISTORY

This road was originally established during the mining boom at the turn of the century and served as the principal way of getting machinery and equipment to the copper mines in the vicinity of Battle Lake. It has also been used continuously since then for livestock and agricultural purposes, first as a mere wagon road, but with the advent of automobile some improvements have been made. Nevertheless, old-timers in the area vouch for the fact that this stretch of road is little different now than it was in the horse and buggy days. It is narrow, crooked, and ungraveled. During the hunting season, four-wheel drive vehicles cut ruts the length of it axle-deep so that at times it's virtually impassable with ordinary touring cars and conventional pickups, especially in wet weather. These conditions exist all year, except, perhaps, for a short period after the forest service is able to run a maintainer over it, probably once a year towards the latter part of the summer. Many places are too narrow for vehicles to pass.

ECONOMICS

The proposed road presently serves the livestock and ranching interests within the forest and upper Snake River area from Rawlins and Saratoga. We are advised that there are 85 million board feet of virgin timber available for harvest. If this road is built, it could feasibly be hauled to Edward Hines Lumber Company mill at Saratoga for processing, a distance of less than 40 miles over favorable grades. There are extensive mineral deposits along the west slope of the continental divide, which in time will be developed and would be served by this road. Of the most pressing and popular need at the present are the recreation facilities within the Medicine Bow National Forest which would be served by this road, as well as hunting. This area has become a favorite recreation and hunting spot for not only the people of Carbon County, but those of Albany County, Laramie County, and eastern portion of Sweetwater County as well, and the improvement of this road would be most conducive to their enjoyment, and it would likewise benefit the livestock, timber, and future mining interests of Carbon County.

COSTS

The information available to us indicates that no damage factor will be involved in the right-of-way since it is entirely on forest lands. We would estimate the cost of the proposed project to be between \$35,000 and \$40,000 per mile.

EMERGENCY

This road has remained virtually in its original condition for well over 75 years, while during that time both incidence and mode of travel have multiplied so greatly that it is hopelessly inadequate to accommodate the present demands which results in an emergency for its reconstruction and the adoption of the proposed industrial project, and that the public interest requires the building of the same.
