TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Art. 3 Sec.9-535 of Municipal Budget Act, W. S. 1957, a Notice of Hearing on the proposed transfer of funds from the Cash Reserve was advertised on June 30, 1973.

OLD RAWLINS HOSPITAL: The following resolution was presented to the Board of Commissioners by the Board of Trustees of Memorial Hospital of Carbon County.

RESOLUTION

BE IT RESOLVED as of June 1, 1973 by the Board of Trustees of the Memorial Hospital of Carbon County, Wyoming, that the old hospital building be abandoned as a facility of the Memorial Hospital of Carbon County, Wyoming, effective as of June 1, 1972, and that the Board of County Commissioners of Carbon County, Wyoming be responsible for the care of that facility from that date on.

BE IT FURTHER RESOLVED, that the Board of County Commissioners be requested to reimburse the Memorial Hospital the sum of \$12,781.42, being the exact costs of maintaining the abandoned structure from June 1, 1972 to June 1, 1973.

BE IT FURTHER RESOLVED, that this Resolution implement the Resolution passed byt this Board on October 11, 1972.

The Commissioners entered into an agreement with the Hospital Board whereby it was agreed that the County would reimburse the Hospital for past maintenance of the old hospital, in the amount of \$12,781.42 and that the County Commissioners would assume future costs as submitted to them by the Hospital Board.
