## SPECIAL MEETING

A special meeting of the Board of County Commissioners was held on January 10, 1973, Niland and McMillen, present, John Niland, Chairman.

The election board for the establishment of the Little Snake River Museum District certified that the vote was 59 for and 6 against the establishment of said district. Therefore, the Board pursuant to Section 18-330.9, Wyoming Statutes, 1957, found and proclaimed that the Little Snake River Museum District was formerly established. Said proclamation was pursuant to motion of Chairman Niland, second of Commissioner McMillen and unanimous approval. It was then moved by Commissioner McMillen, seconded by Niland and unanimously carried that an election of six (6) trustees for said district would be held on Tuesday, January 30, 1973 at Dixon, Carbon County, Wyoming, between the hours of 9:00 o'clock A. M. and 7:00 o'clock P. M. at the Parish House. It was further moved that the County Clerk cause legal notice of said election to be published in the Snake River Press on January 18, 25, 1973

There being no further business to come before the meeting it was adjourned in due form.

CARBON COUNTY PREDATORY ANIMAL BOARD. A motion was made by McMillen, and seconded whereby the following resolution was adopted, to wit:

#### RESOLUTION

WHEREAS, the Board of Directors of the predatory animal district of Carbon, County, Wyoming, has informed the Board of County Commissioners of Carbon County, Wyoming, that their current budget of Fifty Mills (50) which expires June 30, 1973, is insufficient to meet present requirements of predatory animal control within Carbon County, Wyoming; and

WHEREAS, the said predatory animal board has advised the Board of County Commissioners of Carbon County, Wyoming, that an emergency exists at the present time with reference to predatory animals within Carbon County, Wyoming; and

WHEREAS, if urgent measures are not taken forthwith the spring crop of lambs and calves will be seriously decimated; and

WHEREAS, by reason of such insufficiency in the predatory animal district fund of Carbon County, Wyoming, transfer from the cash reserve account should be forthwith made without notice of said transfer all pursuant to Section 9-535, Wyoming Statutes, 1957; and

WHEREAS, the predatory animal board has requested the sum of Four Thousand Dollars (\$4,000.00) to supplement their existing budget to meet said emergency requirements.

NOW, THEREFORE, BE IT RESOLVED that the County Treasurer of Carbon County, Wyoming, be, and he is hereby authorized, directed and empowered to transfer the said sum of \$4,000.00 from the cash reserve account to the predatory animal district fund of Carbon County, Wyoming, forthwith and all without legal publication of notice of transfer.




