WHEREAS, The Board of County Commissioners of Carbon County is desirous of taking advantage of the provisions of Section 24-38, 24-68 and 24-69, W. S. 1957, by cooperating with the State Highway Commission of Wyoming in the construction and/or the improvement of a county road, the extent and location of work which is as follows:

Crush and stockpile gravel for haul and placing by county forces on approximately 8.0 miles of the Spring Creek Road and approximately 4.0 miles of Beaver Creek Road.

NOW, THEREFORE, be it resolved by said Board:

THAT the Board enter into a written agreement with said Commission covering construction and/or improvement in accordance with a contract therefor, now submitted to said Board by said Commission, which agreement is hereby approved and ordered filed in the office of the County Clerk of said County; that the chairman of said Board and the County Clerk of said County be, and they are hereby authorized and directed to execute said contract on behalf of said Board.

I, the undersigned, County Clerk of Carbon County, State of Wyoming, do hereby certify that at a legal meeting of the Board of County Commissioners at which a quorum was present, said Board adopted a resolution of which the foregoing is a full, true and complete copy.


APRIL 4, 1973:

April 4, 1973. The Board resumed its session, all members present, John Niland, Chairman.


