JUSTICE PEACE-ENCAMPMENT: The resignation of Justice Peace-Flora Garinger, Encampment Justice Precinct # 6 effective Dec. 31, 1973 was accepted by the Board. No appointment was made to fill this vacancy.

ELECTION DISTRICT & PRECINCT changes: The Board decided to separate Snake River into three precincts because of the new Election Code which combines municipal-School District trustee and primary and general elections, to be administrated by the County Clerk. Collis-Riverside and Encampment will also be separated into two voting precincts as follows:

SAVAGE
Snake River will now be District No. 14-Precinct No. 1. Dixon will be District No. 14 Precinct No. 2.

Baggs will be District No. 15, precinct No. 1.

Collins-Riverside will be District No. 12 Precinct No. 2- Encampment will be District No. 12, Precinct No. 1
Precinct boundaries will be published before the February Commissioners meeting, at which time the boundaries will be finalized.

PUBLIC DEFENDERS: An agreement was entered into between the Board of County Commissioners and the law firms of C. L. Bates and Brimmer-MacPherson & Golden, pursuant to the provisions of Chapter 164, Session Laws of the State of Wyoming, 1973, to act as Public Defenders. The compensation shall be \$4000.00 to be paid to the Public Defenders in three equal monthly installments on or about the first day of each calender month during the term of this agreement. Term of contract is three months commencing Oct. 1, 1973, to be paid out of Revenue Sharing Funds. This agreement is on file in the office of County Clerk.

COUNTY DEPOSITORYES: Rawlins National Bank, First National Bank, Saratoga State Bank and Rawlins Federal Savings and Loan were designated as County Depositories for the ensuing year.

COUNTY ZONING & PLANNING BOARD: Roland Murphy was re-appointed as a member of the County Planning & Zoning Board, term to expire Dec. 4, 1978.

ELECTION PRECINCTS: The Commissioners decided to change the boundaries of Rawlins voting districts and precincts District No. 2-1 formerly east ward and District No. 2-2-formerly Courthouse, to equalize the number of voters in these precincts as follows:

DISTRICT NO. 2 - PRECINCT 1 - RAWLINS

Beginning at a point at the intersection of East Buffalo St. and Utah St.; thence north to the intersection of East Spruce St. and Utah St.; thence east to the intersection of East Spruce St. and Rodeo St.; thence north on Rodeo St. to the intersection of Rodeo St. and Mahoney St.; thence west on a line projected westerly on the south boundary of the Rawlins Cemetery to Seventh St.; thence north to the city limits; thence east to the city limits; thence south to Highway U. S. 30; thence west to the point of beginning.

DISTRICT NO. 2 - PRECINCT 2- RAWLINS

Beginning at a point at the intersection of East Buffalo St. and Utah St.; thence north to the intersection of East Spruce St. and Utah St.; thence east on East Spruce St. to Rodeo St.; thence north on Rodeo St. to the intersection of Rodeo St. and Mahoney St.; thence west on a line projected westerly on the south boundary of the Rawlins Cemetery to Seventh St.; thence south along Seventh St. to the intersection with Buffalo St.; thence easterly along Buffalo St. to the point of beginning.

Thereupon the Board decided to hold a Special meeting on Jan. 9, at 11:00 A. M. to meet with the Jeffrey Center Board, and at 1:30 P.M. to meet with representatives of the Housing and Urban Development authority, from Denver.
