REGULAR MEETING.

The Board met at 10:00 A. M. Niland and McMillen, present-Orton absent.

The minutes of meetings held Feb. 5 and 6, 1974 were read and approved.

MONTHLY REPORTS of County Officers were audited and placed on file.

TRANSFER OF FUNDS FROM CASH RESERVE: In compliance with Art. 3 Sec.9-535 of Municipal Budget Act, W. S. 1957, a notice of hearing on the proposed transfer of funds from the Cash Reserves was advertised on Feb. 14, 1974. There being no protests entered the Board approved the transfer of funds as follows on motion by Orton, seconded by McMillen and carried, as follows: County Commissioners \$800.00; County Clerk \$2000.00; County Coroner \$1400.00; District Court \$2500.00; Road & Bridge Department \$14,000.00; Water Commissioners \$1500.00; and Elections \$1000.00. Total from cash reserve \$45,700.00. Transferred from the Road & Bridge Department reserve fund, \$16,000.00, to the Road & Bridge general fund.

HOUSING AUTHORITY: A motion was made by McMillen, seconded by Orton and carried whereby the following

resolution entitled, "A Resolution declaring the need for a Housing Authority to function in Carbon Co. Wyo." was adopted, to wit:

RESOLUTION

WHEREAS, there is unsanitary, unsafe, and substandard inhabited dwelling accommodation in Carbon County; and

WHEREAS, there is a shortage of safe and sanitary dwelling accommodations in Carbon County available to persons of low income at rentals or prices they can afford; now, therefore,

BE IT RESOLVED, by the Board of County Commissioners that:

The County of Carbon, Wyoming, herein exercises those housing powers authorized by Section 24, 1-2 and 24, 1-16 of Wyoming Statutes; and that

All prior resolutions of the Board that are in conflict with this authorization are repealed and void.

The motion to adopt the resolution was seconded by Mr. Orton, and upon roll call the following voted:

Ayes: John Niland, Gene McMillen and John Orton. Nays: None

Thereupon the Chairman declared said resolution duly adopted and passed, and signed the same in approval thereof.

The Chairman of the Board of the County of Carbon being present at the meeting, acknowledged notice of the adoption of said resolution.
