BONDS: The bond of Mary Ellen Clark, Sinclair, Wyoming, Clerk-Treasurer, in the amount of \$8,000.00 was approved.

The bond of Evelyn Hansen, Elk Mountain, Wyoming, Town Treasurer, in the amount of \$6,000.00 was approved.

The bond of Agnes A. Stocks, Dixon, Wyoming, Justice of the Peace, in the amount of \$1,500.00 was approved.

CARBON COUNTY ZONING OFFICE: A motion was made by John Glode and seconded by Emil T. Lemich that the Sierra Madre Subdivision be refered back to the Planning Commission for further consideration, including but not limited to the August 13, 1975 Correspondence from Wyoming State Highway Department, Construction engineering cost estimates and appropriate bond or financial assurances. The motion was carried.

A motion was made by John Glode and seconded by Emil T. Lemich to refer the matter concerning regulations and control of Sub Division land<sup>n</sup>unincorporated areas of the County ( as provided for under enrolled act no. 75 of 1975 Legislative Session) to the County Atty.office for drafting in resolution form. The motion was carried.

The Board resumed its session, John Orton, John Glode and Emil T. Lemich present, Orton, Chairman.

Bell Telephone Co. presented a proposal for a new telephone system in the Courthouse. The proposal was taken under advisement.

RETAIL MALT BEVERAGE PERMIT was granted to Frank E. & Roberta Erickson d/b/a/ 3 Ford Muddy Gap Service, Lander Route, Rawlins. There being no protests entered, License No. 339, 9-8-75 to 9-8-76 was granted.

OLD HOSPITAL. The Board authorized and directed the County Attorney to prepare a tentative draft of a long-term lease for the leasing of the old hospital.

WELFARE BUILDING LEASE. It was regularly moved by Orton, seconded by Glode and unanimously carried that the Board execute and deliver to L. M. Olson, lessor, the renewal lease of the welfare premises.

SHERIFF'S ADDITION TO COURTHOUSE. The Board reviewed the plans presented by Hitchcock & Hitchcock, Architects, and gave their approval.

FIRST HIGHLAND HILLS ADDITION to the City of Rawlins: The plat of the First Highland Hills Addition, located in the E½ of Sec. 9, T. 21 N., R. 87 W., 6th P.M., County of Carbon, State of Wyoming, dedicated by East Rawlins Ventures, was approved by the Board for filing with the County Clerk and for conveyance to the County of public dedications shown thereon; subject to the provision that approval in no way obligates Carbon County for

financing or constructing of improvements on lands, streets, or easements dedicated to the public except as specifically agreed to by the Board of Commissioners and further that said approval shall in no way obligate Carbon County for maintenance of streets which are not dedicated to the public nor until all improvements shall have been completed to the satisfaction of the Board of County Commissioners and accepted by proper resolution.

THE MCFADDEN-ARLINGTON ROAD. Project Agreement OS-0601(1):

R E S O L U T I O N

WHEREAS, the Board of County Commissioners of Carbon County wish to utilize the provisions of Section 219, Title 23, United States Code, "Off-System Roads" (Section 122 of the Federal-Aid Highway Amendments of 1974) by cooperating with the Wyoming State Highway Commission in the construction or the improvement of a county road, the extent and location of work which is as follows:

Provide supplemental funds for Project SC-CFM 6-13, The Arlington-McFadden Road, beginning at a point on FAS Route 0105 in the SW¼ SW¼ Section 31, T20N, R77W extending southwesterly for approximately 7.66 miles to the Arlington Interchange on FAI Route 80-4.

NOW, THEREFORE, be it resolved:

THAT the Board enter into a written agreement with Wyoming State Highway Commission covering said construction or improvement in accordance with the agreement attached hereto which is hereby approved and ordered filed in the office of the County Clerk of this county; that a majority of the Board and the County Clerk of the county be, and they are hereby authorized and directed to execute the agreement on behalf of the Board.
