CARBON COUNTY HISTORICAL SOCIETY & CARBON COUNTY WELFARE BOARD: John Glode was appointed to represent the Commissioners.

DEPUTY COUNTY ASSESSOR: Merwyn N. Powell, Saratoga, Wyoming, was appointed Deputy County Assessor.
