HOSPITAL BOARD: A delegation from the Hospital Board requested approval of funding of a contract with World Wide Health Consultants, Inc. The Board entered into a contract with WWHC for the solicitation of four doctors to provide medical services within Carbon County, as follows:

Agreement between THE CLIENT and WORLD WIDE HEALTH CONSULTANTS INC. (W.W.H.C.)

- 1. It is agreed that W.W.H.C. be retained to represent THE CLIENT for the purpose of recruiting physicians on a non-exclusive basis.
- 2. It is agreed that THE CLIENT will notify W.W.H.C. promptly when physician openings have been filled.
- 3. It is agreed that THE CLIENT will make available to W.W.H.C. a completed data sheet, appropriate literature and employment forms upon request.
- 4. It is agreed that THE CLIENT will pay W.W.H.C. a placement fee of 15% of the first year's base salary or guarantee of each and every physician placed by W.W.H.C. with THE CLIENT. The fee is to be paid to W.W.H.C. within ten days from the date that the physician(s) has been hired. Should THE CLIENT not offer a guarantee or salary to the physician(s) then the fee will be \$4,500.00 for each and every physician placed.
- 5. It is agreed that any and all information given to THE CLIENT regarding candidates shall be considered privileged between THE CLIENT and W.W.H.C. and will not be used by any other outside party.
