# RESOLUTION

WHEREAS, the Board of County Commissioners of Carbon County wish to utilize the provisions of Section 230, Title 23, United States Code, 405, "Safer Road Demonstration Program", by cooperating with the Wyoming State Highway Commission in the construction or the improvement of a county road, the extent and location of work which is as follows: nad

16.2 miles south of the southerly end of Wyoming Secondary Highway 71 (The Sage Creek Road).  
Replace timber bridge with a double structural plate pipe.

NOW, THEREFORE, be it resolved:

THAT the Board enter into a written agreement with the Wyoming State Highway Commission covering said construction or improvement in accordance with the agreement attached hereto which is hereby approved and ordered filed in the office of the County Clerk of this county; that a majority of the Board and County Clerk of the county be, and they are hereby authorized and directed to execute the agreement on behalf of the Board.

To cover the placing of telephone plant on County Road right of way, buried cable, right of way number 14658 Amend., south west of Saratoga, located in Sections 24, 25, 26, 35, T. 17N, R. 84W, and Sections 3, 9, 16, 17, 20, 29, 30, 31, T. 16N., R. 84W, and Section 6, T. 15N., R. 84W, and Section 1, T. 15N, R. 85W.

To cover the placing of telephone plant on County Road right of way, buried cable, in Section 31, Township 16N, Range 83W, located in Saratoga, Wyoming.
