September 14, 1976 - Primary Election Day

August 14, 1976 is last day to register with County or City Clerk before Primary Election Day and voter registration is also permitted at the polls on Primary Election Day.

Filing Offices and Dates

- July 16-30: File with Secretary of State for national and state offices;  
County Clerk for county, college and school board, and precinct  
committeemen and committeewomen offices.
- July 16-Aug. 4: File with City Clerk for municipal offices.

Campaign Reporting Requirements

All candidates must file a statement of campaign receipts and expenditures by September 24th. One copy is to be filed with Secretary of State and one copy with the County Clerk. A candidate who fails to file a full and complete itemized statement within time required is guilty of a misdemeanor and no such candidate shall receive a certificate of nomination or election, nor shall he enter upon the duties of the office, and a vacancy shall exist.
