CONSTITUTIONAL AMENDMENTS

Amendment No. 1. This proposed amendment to the Constitution of Wyoming permits a vote by the people on the question of retention of an incumbent judge in office without the prior approval of the judicial nominating commission.

Amendment No. 2. This amendment will increase the amount of debt that may be incurred by any county from two percent (2%) to four percent (4%) of the assessed value of the taxable property in the county: will increase the amount of debt that may be incurred by any city or town from four percent (4%) to eight percent (8%) of the assessed value of the taxable property in the city or town; will increase the amount of debt that may be incurred by any school district from ten percent (10%) to fifteen percent (15%) of the assessed value of the taxable property in the school district; and will remove any limitation on indebtedness incurred for supplying water or sewage disposal systems to any county, city or town.

Amendment No. 3. This amendment allows venue of an offense to be placed in the county or district where the corpus delicti is found, or in any county or district in which the victim was transported, when the location of an offense involving a motor vehicle, railroad car, aircraft or other form of transportation cannot be determined with certainty.

the following questions:

"Shall the Baggs Solid Waste Disposal District make an annual levy, not to exceed three (3) mills on the dollar of assessed valuation of the district, to operate the district?"

CAMPAIGN REPORTING REQUIREMENTS - All candidates must file a statement of campaign receipts and expenditures by November 12, 1976. One copy is to be filed with Secretary of State and one copy with the County Clerk. A candidate who fails to file a full and complete itemized statement within time required is guilty of a misdemeanor and no such candidate shall receive a certificate of nomination or election, nor shall he enter upon the duties of the office, and a vacancy shall exist.
