November 4, 1976

The Board resumed its session, John Orton, John Glode and Emil T. Lemich present; Orton, Chairman.

HEALTH SYSTEMS RESEARCH INSTITUTE - The Commissioners met with HSRI to discuss renewal of their contract with Carbon County which expires November 11, 1976. The HSRI contract has provided Carbon County with five doctors to date. The object of HSRI is to provide health services for small communities and the program in Carbon County can only work with the cooperation of all parties involved. The Commissioners said that all other programs to recruit doctors for this area had failed and HSRI was the only organization successful in bringing new physicians to Carbon County. Harold Johnson added that an acute medical situation in the County had been alleviated. He also thought the County had benefited from the HSRI program and that a 30 per cent income increase at the hospital offset the deficit of running the HSRI clinic. Dort Tikker said that the five HSRI doctors might not remain, because of contractual obligation to HSRI, if the HSRI program were terminated. Commissioner Glode said that because of the HSRI program the Carbon County Memorial Hospital is very close to the breakeven point. Some \$264,000 had been generated by the HSRI program to date and this figure would be \$300,000 by the first of the year and probably up 50 per cent next year, since it takes time for new doctors to reach full economic potential. Commissioner Glode said that HSRI officials will work on a contract proposal to see whether they can work something out that would be agreeable to both the County and HSRI. No action was taken in renewing the contract by the Board.

RAWLINS-CARBON COUNTY ZONING & PLANNING. It was moved by Glode and seconded by Lemich and unanimously carried to allow the petition of James H. Crowe, Saratoga, Wyoming for a zone change from RAM (Ranching, Agriculture and mining) to RD (Residential Development) containing 40 acres more or less of Section 6, Township 14, Range 83, Carbon County Wyoming.

MOUNTAIN BELL BURIED TELEPHONE CABLE:

Survey of Right-of-Way No. 16911 Buried Telephone Cable-Carbon County, Wyoming for proposed Saratoga RL 10 line to be constructed across Section 25, Township 17N, Range 83W was approved by the Board of Commissioners.

WELFARE BUILDING - Approval was given by the Board for the State Probation and Parole Department to use the space now available in the Welfare Building.

SHEEP MOUNTAIN RADIO SITE - A request for Amoco Pipeline to share the County's Sheep Mountain radio site for installation of a 450MHz repeater system was granted after Western Transmission has moved their system to Separation Peak. Rental will be \$30.00 per month with the County providing power, building and tower space.

RAWLINS-CARBON COUNTY AIRPORT BOARD CITY-COUNTY AGREEMENT - A motion was made by Lemich and seconded by Orton with Glode abstaining to adopt the following Resolution:

RESOLUTION

RESOLVED that the Chairman of the Board of County Commissioners of Carbon County, Wyoming, and the Clerk of the Board of County Commissioners of Carbon County, Wyoming, be, and they are hereby authorized to execute on behalf of the Board of County Commissioners of Carbon County, Wyoming, an agreement with the City of Rawlins, Wyoming, pertaining to the establishment of the Rawlins-Carbon County Airport Board, a copy of which agreement is attached hereto as Exhibit "A" and made a part hereof.

## COMPOSITION OF BOARD

The Board shall consist of five (5) member, all of whom shall be qualified electors of Carbon County. The initial Board shall be comprised of those individuals presently serving on the City Airport Board with terms expiring as follows:

Thereafter appointments for a full term of five years shall be made alternately by the city and county governing bodies during their January meeting of each year, it being agreed that the County shall proceed first in the alternating schedule by appointing a full term member during its January, 1977 meeting, then the City during its January, 1978 meeting, ad infinitum. Vacancies for unexpired terms shall be filled by appointment of the governing bodies of the City and County acting jointly and the appointee so selected shall serve the remaining term of his predecessor so as not to disturb the alternating appointment schedule set forth hereinabove. Members of the Board may be removed for cause by the joint action of the City and County. A full, true and complete copy of the Rawlins-Carbon County Airport Board City-County Agreement is on file in the office of the County Clerk.
