PROCLAMATION AND NOTICE OF ELECTION ON QUESTION OF WHETHER THE LITTLE SNAKE RIVER CONSERVANCY DISTRICT SHOULD ENTER INTO A REPAYMENT CONTRACT WITH THE UNITED STATES  
RESOLUTION NO.12

-0-

WHEREAS, Little Snake River Water Conservancy District (herein referred to as the "District"), in the County of Carbon, State of Wyoming, is a public corporation duly organized and existing under the Constitution and laws of the State of Wyoming and was duly organized pursuant to the provisions of S41-77 through 41-117 Wyoming Statutes, 1957 as amended, and the District as originally incorporated has never been reorganized nor wholly or partially annexed to or consolidated with any other public corporation; and

WHEREAS, the members of the Board of Directors of the District (herein referred to as the "Board") and the officers have been duly appointed, elected or chosen and qualified; and

WHEREAS, the interests of said District and public interest and necessity demand and require:

1. The construction, operation and maintenance of the Savery-Pot Hook Project, a participating project of the Colorado River Storage Project; and
2. The making of a Repayment Contract with the United States of America to carry out said object and purpose of the District; and
3. A greater expenditure than the ordinary annual income and revenue of the District will permit in order to satisfy this public interest and necessity; and

WHEREAS, the Board is of the opinion that the portion of the cost of the construction, operation and maintenance of the Savery-Pot Hook Project which is the obligation of the District pursuant to the applicable laws and requirements of the United States of America should be paid as set forth in the provisions of the Repayment Contract between the United States of America and the Little Snake River Water Conservancy District, a copy of which is incorporated herein, attached hereto as Exhibit A and copies of which are on file in the office of the District in Savery, Wyoming at the residence of John T. Cobb and

WHEREAS, said 41-103, Wyoming Statutes, 1957 as amended, provides that whenever the Board of the District by resolution adopted by a majority of such Board, shall determine that the interests of said District and the public interest and necessity demand the making of a contract with the United States to carry out the objects and purposes of said District wherein no obligation is created, to satisfy which requires a greater expenditure than the ordinary annual income and revenue of the District permits, said Board shall order the submission of the proposition of making such contract to the qualified electors of the District, at an election held for that purpose; and

WHEREAS, the Board of said District now deems it necessary and desirable that a Resolution be adopted calling for an election on the question of making such contract with the United States:

NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE BOARD OF DIRECTORS OF THE LITTLE SNAKE RIVER WATER CONSERVANCY DISTRICT IN THE COUNTY OF CARBON, STATE OF WYOMING:

Section 1. The Board of Directors of the District has determined, and hereby determines that the interest of said District and the inhabitants therein, and the public interest and necessity demand and require the construction, operation and maintenance of the Savery-Pot Hook Project to carry out the objects and purposes of the District, and require the making of a Repayment Contract with the United States to provide, among other things, for the payment by the District to the United States of that portion of the cost of the Project which is the obligation of the District pursuant to the applicable laws and requirements of the United States of America.

Section 2. The purposes and effects of the Repayment Contract are to provide, among others, for the construction, operation and maintenance of the Savery-Pot Hook Project, for the delivery of Project water from the Project works for the irrigation of irrigable land within the Little Snake River Snake Water Conservancy District, and for the payment of said portion of the cost of the project. Payment of said contract obligations by the District will require a greater expenditure than the ordinary annual income and revenue of the District will permit.

Section 3. The total estimated cost of the Savery-Pot Hook Project is \$75,700,000.00. The obligation of the District is to pay a portion of such cost as stated in said Repayment Contract, pursuant to the applicable laws and requirements of the United States of America.

Section 4. All action heretofore taken (not inconsistent with the provisions of this Resolution) by the District and the officers thereof, directed toward the objects and purposes hereinabove stated and the making or entering into said Repayment Contract with the United States be and the same hereby is ratified, approved and confirmed.

Section 5. The proposed Repayment Contract between the United States of America and the Little Snake River Water Conservancy District for the Savery-Pot Hook Project is incorporated herein, attached hereto as Exhibit A and copies thereof are on file at the office of the District in Savery, Wyoming at the residence of John T. Cobb.

Section 6. A special election on said Repayment Contract of the registered electors of the District shall be held within the boundaries of said District on March 15, 1977 between the hours of 8 o'clock a.m. and 7:00 o'clock p.m. at which election there shall be submitted to such electors the question of making or entering into said Repayment Contract, which question shall be substantially in the following form:

REPAYMENT CONTRACT QUESTION SUBMITTED:

Shall the Little Snake River Water Conservancy District, State of Wyoming, be authorized to make and enter into a Repayment Contract with the United States providing for the construction, operation and maintenance of the Savery-Pot Hook Project, the payment by the District to the United States of that part of the \$75,700,000.00 total estimated cost of the Project which is the obligation of the said District as stated in said Repayment Contract pursuant to the applicable laws and requirements of the United States, and among other things, to provide for the delivery of Project Water from the Project works for irrigation, and for the operation, maintenance and replacement of Project works; said contract to extend over a period of fifty (50) years from the date of completion of the Project and delivery of the water therefrom; and said payments to be made at such time and in such manner and upon such terms and conditions, with such covenants and agreements and with such other detail as set forth in said Repayment Contract and as determined by the Board of Directors of the District all in accordance with 41-102 Wyoming Statues, 1957 amended and a Resolution of the Board of Directors adopted.

Section 7. The official paper ballot for use by qualified electors shall show the nature of the question submitted and such ballots for use at the election shall be prepared by the Secretary of the District and furnished to the County Clerk of the County and the Judges of the election, to be by them furnished to the electors. The ballots shall be in substantially the following form:

QUESTION: Shall the Little Snake River Water Conservancy District, State of Wyoming, be authorized to make and enter into a Repayment Contract with the United States providing for the construction, operation and maintenance of the Savery-Pot Hook Project, the payment by the District to the United States of that part of the \$75,700,000.00 total estimated cost of the Project which is the obligation of the said District as stated in said Repayment Contract pursuant to the applicable laws and requirements of the United States, and among other things, to provide for the delivery of Project Water from the Project works for irrigation, and for the operation, maintenance and replacement of Project works; said contract to extend over a period of fifty (50) years from the date of completion of the Project and delivery of the water therefrom; and said payments to be made at such time and in such manner and upon such terms and conditions, with such covenants and agreements and with such other detail as set forth in said Repayment Contract and as determined by the Board of Directors of the District all in accordance with Section 41-102 of the Wyoming Statutes, 1957 as amended and a Resolution of the Board of Directors adopted.

A map showing the description of the boundaries of the Little Snake River Water Conservancy District in the County of Carbon and showing the boundaries of the Little Snake River Water Conservancy District election precinct for this election is now on file in the office of the Secretary of the District at John T. Cobb, Savery, Wyoming and is available for public inspection. Copies of said map shall also be on file in the office of the County Clerk and Ex Officio Register of Deeds of Carbon County, Wyoming. Any registered elector may determine the boundaries of the District election precincts by inquiry directed to either the Secretary of the District or the County Clerk and Ex Officio Register of Deeds of the County. Said map is attached to this Resolution as Exhibit "B".

Each election official shall receive \$2.30 per hour as compensation for his or her services.

Section 9. The respective election boards shall conduct the election in their respective precincts in the manner prescribed by law for the holding of general elections and shall make the returns to the secretary of the District. At any regular or special meeting of the Board of Directors held not earlier than five days following the date of the election the returns thereof shall be canvassed and the results declared.

Section 10. No ballot for or against said question shall be received by the Judges of Election unless the person offering the same shall be a registered elector residing in the District. Absentee voting will be permitted for said election in the manner provided by law.

Section 11. The Judges of Election may require the execution of an affidavit concerning the qualifications of any elector which affidavit shall be in substantially the following form:

Section 12. Immediately after the closing of the polls, the Judges of Election shall open the ballot box, count the ballots and promptly certify the results and make their returns to the Secretary of District.

Section 13. This Resolution shall be published once a week for two consecutive weeks, the last publication of which shall be not less than twenty nor more than thirty days before the date set for said election, in the Rawlins Daily Times, the newspaper which is a newspaper of general circulation within the District, and no other or further notice of such election, or publication of the names of election officials, or precincts or polling places need be given or made.

Section 14. The officers of the District be, and they hereby are, authorized and directed to take all action necessary or appropriate to effectuate the provisions of this Resolution.

Section 15. All orders, by-laws and resolutions, or parts thereof, in conflict with this Resolution are hereby repealed.

Section 16. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the validity or unenforceability of such section, paragraph or clause or provision shall not affect any of the remaining provisions of this Resolution.

Section 17. This Resolution will promote the health, safety, prosperity, security and general welfare of the inhabitants of the said District; an emergency is hereby declared to exist; and this Resolution shall become effective and be in force immediately upon its adoption.

This lease is made and entered into this 1st day of April, 1977, by and between the County of Carbon, a Wyoming municipal corporation, with its office situated at Rawlins, Wyoming 82301, herein called Lessor, and Amoco Pipeline Company, A Maine corporation, with its division office at 700 Security Life Building, Denver, Colorado 80202, herein called Lessee.

1. The Lessor does hereby lease to the Lessee the right to install one 450hz repeater on its antenna as shown on the attached map identified as Exhibit A.
2. Lessee shall pay Lessor a sum of Three Hundred Sixty Dollars (\$360.00) per year in advance as rental. The term of this lease shall be for one year, beginning April 1, 1977, and from year to year thereafter unless cancelled by either party by giving 60 days' written notice in advance of the effective date of the termination. Termination shall be effective only at the end of any annual term.
3. Lessor shall have the right to direct Lessee as to the location of any of its equipment on its antenna mast. Lessee shall have access to the premises and to the buildings at any time, day or night. Lessor shall have no obligation, however, to provide any security for Lessee's equipment.
4. Lessee assumes all risk for the safety and maintenance of its equipment. Lessee agrees that it shall not permit any lien of any nature to affix to property of Lessor.

6. This lease and its provisions shall be binding upon the parties hereto, their successors, legal representatives, and assigns.
