#### Campaign Reporting Requirements

All candidates must file a statement of campaign receipts and expenditures by September 23rd with the County Clerk. A candidate who fails to file a full and complete itemized statement within the time required is guilty of a misdemeanor and no such candidate shall receive a certificate of election, nor shall he enter upon the duties of the office, and a vacancy shall exist.

Every political action committee supporting a school or college board candidate, and every candidate's campaign committee shall file a statement of campaign receipts and expenditures by September 20th with the County Clerk.

Suppliers of campaign advertising are to file an itemized statement by September 20th with the Secretary of State.

#### RAWLINS-CARBON COUNTY ZONING & PLANNING

Matt Baclawski presented a copy of an application for Public Works Senior Citizens Multi-Purpose Center LPW Grant which he has submitted to the Wyoming Department of Economic Planning & Development.

An amendment to the Carbon County Zoning & Subdivisions Resolution were presented to the Commissioners.

ADENDUM TO THE CARBON COUNTY SUBDIVISION RESOLUTION OF 1972: UNDER SECTION IV PROCEDURES 4.5 SUPPORTING DATA CHANGE ITEM "A" TO READ: "Each subdivider will be required to provide water for an adequate water supply and distribution system. The estimated gallons per day of water requirements plus test data for well capacity and quality if wells are proposed must be submitted with application for final plat. Water system plans must carry the stamp of approval of the Wyoming Department of Environmental Quality."

The amendment was tabled a second time by the Commission.

Herb Hogue, County Planner, recommended that the Carbon County Zoning & Planning Staff be placed under the direction of Carbon County Council of Governments.

#### CARBON COUNTY ZONING & PLANNING COMMISSION

##### RESOLUTION

WHEREAS, the City of Rawlins has specific statutory authority to establish a Zoning Commission pursuant to Title 15.1, Chapter C 1, Article A 7, Wyoming Statutes, 1957; and

WHEREAS, Carbon County, Wyoming, a body politic and corporate has specific statutory authority to establish a zoning and planning commission pursuant to Title 18, Chapter 6.1, Wyoming Statutes, 1957; and

WHEREAS, pursuant to enabling Act, the said City of Rawlins, and County of Carbon have established a joint planning and zoning commission; and

WHEREAS, the Board of County Commissioners of Carbon County, Wyoming, find that it is in the best interest of the person and property situated in the unincorporated portions of Carbon County, Wyoming, that said joint City of Rawlins, County of Carbon Zoning Commission be dissolved; and

WHEREAS, the best interest of the persons and property situated in the unincorporated portions of Carbon County, Wyoming would be best served by a Carbon County Zoning and Planning Commission,

NOW, THEREFORE, BE IT RESOLVED:

1. That the Board of County Commissioners of Carbon County, Wyoming, does hereby find that the best interests of the inhabitants and property situated in the uninhabited portions of Carbon County, Wyoming, is best served by a single planning and zoning commission.

2. That Carbon County, Wyoming, does hereby withdraw from the joint City of Rawlins - Carbon County Planning and Zoning Commission and the functions of said County shall cease and terminate as of the date of this Resolution.

3. That the City of Rawlins acting by and through its Mayor and Governing Body and Carbon County, Wyoming, acting by and through its Board of County Commissioners shall equitably and reasonably apportion the

assets and liabilities of said joint body and effect transfer of the same to the separate entities forthwith.
