COMMISSIONER'S PROCEEDINGS  
SPECIAL MEETING

The Board of Commissioners met at 8:00 P.M., John Glode, Emil T. Lemich and Martin McMahon present; Glode, Chairman, to hear all persons relative to the 1977-1978 budget requests. A motion was made by Lemich, seconded by McMahon and carried whereby the following resolution was adopted, to wit:

APPROPRIATION RESOLUTION

WHEREAS, on the 15th day of June, 1977, Mary G. Bradford, County Clerk, the budget making authority, prepared and submitted to the Board a county budget for the 1977-1978 fiscal year ending June 30, 1978.

WHEREAS, such a budget was duly entered at large upon the records of this Board and a copy thereof was made available for public inspection at the office of the County Clerk; and

WHEREAS, notice of a public hearing on such budget, together with the summary of said budget, was published in the Rawlins Daily Times, a legal newspaper published and of general circulation in the county on the 8th day of July, 1977 and

WHEREAS, a public hearing was held on such budget at the time and place specified in said notice, at which time all interested parties were given an opportunity to be heard; and

WHEREAS, following such public hearing certain alterations and revisions were made in such proposed budget, all of which more fully appear in the minutes of this Board.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners that the county budget, as so revised and altered, be adopted as the official county budget for the 1977-1978 fiscal year ending June 30, 1978,

BE IT FURTHER RESOLVED, that the following appropriations made for the 1977-1978 fiscal year ending June 30, 1978 and the expenditures of each officer, department or spending agency be limited to the amount herein appropriated.

Campaign Reporting Requirements

All candidates must file a statement of campaign receipts and expenditures by September 23rd with the County Clerk. A candidate who fails to file a full and complete itemized statement within the time required is guilty of a misdemeanor and no such candidate shall receive a certificate of election, nor shall he enter upon the duties of the office, and a vacancy shall exist.

Every political action committee supporting a school or college board candidate, and every candidate's campaign committee shall file a statement of campaign receipts and expenditures by September 20th with the County Clerk.

Suppliers of campaign advertising are to file an itemized statement by September 20th with the Secretary of State.
