## CARBON COUNTY PLANNING &amp; ZONING

The Center presented a budget request to the Commissioners for \$59,500. No action was taken.

THAYER INTERCHANGE

A group of residents from the South Side Area of Rawlins asked for the support of the Commissioners in endorsing Wyoming Highway Department's alternative A-4 Plan.

- (a) Thayer Interchange on I-80
- (b) Harshman Street Overpass connecting with Interchange
- (c) Service road connecting Sage Creek Road with the Thayer Interchange.

The Commissioners will take the request under advisement.

JENKINS PROJECT

Utility Fuels, Inc., a Texas Corporation, conveyed to the County of Carbon, in the State of Wyoming, its right, title and interest in and to that certain right-of-way and easement for a public road across property owned by Kerr-McGee Nuclear Corporation in the South 1/2 of the Southwest 1/4 of Section 2, and in the Northeast 1/4 of the Northwest 1/4, Section 11, T.27N., R.78W., 6th P.M., Carbon County Wyoming. An Agreement was executed between Carbon County Wyoming, and Utility Fuels, Inc.

UFI is presently in the process of developing an uranium mine generally described as the "Jenkins Project", which is located in portions of Sections 2, 3, 9, 10, 11, 14, and 15, of T27N, R78W, of the 6th p.m., Carbon County, Wyoming. In conjunction with said project, it has been necessary to move and relocate an existing rural road which was located in the northern portion of Sections 10 and 11, T27N, R78W of the 6th p.m. As relocated, the rural road will pass through portions of Sections 11, 2, 3, and 10, T27N, R78W, of the 6th p.m. The relocated rural road has been designed under standard criteria and the required warning signs have been installed. In order that the relocated road be properly classified as a "County Road" it is necessary that the formerly existing road be legally abandoned and that the relocated road be properly and legally adopted as a County Road. As of this date, application has been made to the State of Wyoming and to the Bureau of Land Management by Carbon County for the necessary permits for the location of the said road on state and federal property and UFI has delivered to Carbon County a right-of-way and easement for a public road obtained from Kerr-McGee Nuclear Corporation. Without in any manner recognizing or adopting any legal responsibility for the maintenance of said rural road, UFI has agreed to contribute the sum of \$5,000.00 to the maintenance of certain portions of the said rural road, said sum to be paid by UFI to a contractor chosen by Carbon County to provide said Maintenance.

RESOLUTION

WHEREAS, the Board of County Commissioners deem it in the public interest to establish, locate, relocate and abandon parts of County Roads 2 and 291;

WHEREAS, the point of commencement, the course and point of termination of said roads to be established, altered or vacated as the case may be, are attached and incorporated herein by this reference in the respective notices;

NOW, THEREFORE, BE IT RESOLVED, pursuant to Section 24-3-101, Wyoming Statutes, the County Attorney shall start proceeding to do the same by arranging publication of the required notices of public hearing.

Dear Mr. Bonham:

This letter is written in response to the written report above noted. The contents have been noted both with the examiners and other elected officials. Contrary to the statement therein made on page 7, paragraph 9, "there appeared to be no disagreement with the comments", there is in fact serious disagreement and the audit reflects a gross violation of good and proper field audit practices.

On page 3, paragraph 6, MOTOR VEHICLE reads in part:

"Several times 10% was used instead of 15% for the 6th year of use."

The County Treasurer advises as follows:

Since the computer demands that only the actual valuation appears in the designated column, vehicles purchased and licensed in April (2/3 year) appear to have only a 10% valuation, e.g.: factory cost -  $4500 \times 15\% = 675$ ;  $2/3 \times 675 = 450$  -- the same as 10% of 4500.

So in fact fifteen percent (15%) was used as required.

On page 9, paragraphs 9 and 10, a thorough field audit of the Lemich and Michie expenditures would have revealed the following facts. The only rooms available to them at the time was a single and a double occupied by Lemich and Michie respectively. It was a four (4) night occupancy; the single room was vacated the fourth night. Moreover, the sum of \$177.62, which is the amount you disallowed to Michie in your audit, is greater than the amount of the warrant paid to him, namely, \$170.09. We also state that the State of Wyoming travel regulations as applied to state employees has no application to county employees. The Board is governed by actual incurred expenses so long as they are reasonable and prudent. The Lemich expenditures include room charges for both himself and Michie. The Michie voucher included meals for both himself and Lemich. The room and board for them in Las Vegas, Nevada, came to \$62.00 per day. A courtesy call to both of those involved would have revealed the true facts -- rather than raise the unsinuations and innuendos as done by your examiner.

This report is in fact an insult to the good people of Carbon County, Wyoming, and to their dedicated and loyal elected officials and employees. And particularly, it is a cheap political attempt to scandalize and defame the two Democratic members of the Board of County Commissioners and the Chairman of the Democratic Party of Carbon County, Wyoming.

The Board must therefore reject the overall tenor of this report and request the Governor to purge the office of State Examiner of politically orientated members and replace them with professional auditors -- who can do their job in a professional manner without political considerations. Politics has no place where the tax dollars of our constituents are to be judiciously considered.
