COMMISSIONER'S PROCEEDINGS
SPECIAL MEETING

The Board of County Commissioners met at the Saratoga Inn, Saratoga, September 14, 1978 at 1:00 P.M.. Glode, Lemich & McMahon present, Glode, Chairman.

HANNA MEDICAL CLINIC

Motion was made by Lemich and seconded by McMahon and unanimously carried that the County negotiate a contract for the opening of a Medical Clinic in Hanna to provide medical services to the people of Hanna and surrounding area and will accept proposals from interested persons. Publication to be made in a legal paper of general circulation. Glode-aye, Lemich-aye, McMahon-aye.

KARSTOFT-ANDERSON PRIVATE ROAD PETITION

The Commissioners met on the site to determine whether a private road was necessary leading to real property owned by William Anderson, Richard F. Karstoft and Margaret E. Karstoft located in the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 21, Township 16, Range 83W of the 6th P.M., Carbon County, Wyoming. The following Order was issued:

ORDER APPOINTING APPRAISERS

Hearing was held upon this matter at the scheduled time of 2 o'clock P.M. on Tuesday, September 5, 1978. After listening to the presentations of the parties, the Commissioners make the following FINDINGS OF FACT: 1. The Petitioners have complied with the law on Establishment of Private Roads (Section 24-9-101, et seq.). 2. A private road is necessary to allow Petitioners access to their property within this county. 3. Three disinterested freeholders and electors should be appointed, as provided by statute, to establish a private road. WHEREFORE, we, the County Commissioners of Carbon County, do hereby appoint the following-named individuals: s/Curtis Rochelle, s/ George Allen, s/ John McNellis, who are disinterested freeholders and electors of Carbon County, and we hereby direct them to take and subscribe to an oath that they will faithfully and impartially perform their duties, that they will meet on the 20th day of October, 1978, to view subject property and locate a private road, not exceeding thirty (30) feet in width, from a certain point on the premises of the Petitioners to a certain point on a public road, so as to do the least possible damage to the lands through which said private road shall run, to assess damages, and to make a full and true return to the next regular session of the County Commissioners, after which said viewers and appraisers shall meet, said return including a plat of said road, the amount of costs, the amount of damages, and to whom said costs and damages shall be paid.
