There being no protests, the Commissioners approved the renewal of a Retail Liquor License to James L. & Elna P. Hewitt, dba Gay Johnson Travel Center - A portion of Section 23, Township 21 North, Range 88 West.

RETAIL MALT BEVERAGE PERMIT

There being no protests, the Commissioners approved the renewal of a Retail Malt Beverage Permit to Alice G. Vondrasek, dba Red Hills Service Station - a Portion of Section 34, Township 28, Range 89 West of the 6th P.M. in Cement Block Building, North Room.

There being no protests, the Commissioners approved the renewal of a Retail Malt Beverage Permit to Max B. Leach, dba Lamont Service - A frame Building located in the NW $\frac{1}{4}$ of Section 21, Township 26, Range 89 West of the 6th P.M. and known as Lamont Service.

CARBON COUNTY PLANNING & ZONING

A motion was made by Lemich, seconded by McMahon and unanimously carried to approve Case File No. 77-60, Overlook Retreat #2, William Richardson, 930 Mt. View Blvd., Rawlins, Wyoming for final plat approval and zone change from RAM to RD-40,000 of the Overlook Retreat No. 2 Subdivision located in the Turpin Reservoir area in the Medicine Bow National Forest. Site consists of 40 acres, 27 lots, legally described as SE $\frac{1}{4}$ of NE $\frac{1}{4}$ Section 15, Township 17N, Range 80W, Carbon County, Wyoming.

A motion was made by Lemich, seconded by McMahon and unanimously carried to approve Case File No. 78-41 Tullis Land Co. by C. W. McIlvaine, President, Box 1070, Saratoga, Wyoming, for a zone change (Ref. Carbon County Zoning Resolution, Section 570) from R.A.M. (Ranching, Agriculture and Mining) to RD-40 (Residential Development) on 640 acres located approximately 2 $\frac{1}{2}$ miles northeast of Saratoga, Wyoming. The property is proposed to be subdivided into sixteen forty acres tracts and is legally described as all of Section 29, Township 18N, Range 83W Carbon County, Wyoming.

A motion was made by Lemich, seconded by McMahon and unanimously carried to approve Case File No. 78-46, Abe DeHerrera & Association, 213 W. Center St., Rawlins, Wyoming, for a Zone change from RAM (Ranching, Agriculture and Mining) to RD-40 (Residential) to allow placement of recreational cabins for membership club. Site consists of 40 acres located in the Savery Creek area adjoining the Medicine Bow National Forest, legally described as SE $\frac{1}{4}$ of NE $\frac{1}{4}$, Section 21, Township 16N, Range 87W, Carbon County, Wyoming.

A motion was made by Lemich, seconded by McMahon and unanimously carried to approve Case File #78-3A, amendments to the Carbon County Zoning Resolution, Section 300-District Regulations:

1. Item 312.3 under Subsection 312-Special Permit Uses; shall be changed to read: Public buildings and schools.
2. Item 324-1 under Subsection 324-Lot and Yard Requirements; shall be changed to read: Minimum lot area and width for lots without either a public or State approved community water supply or sewage system.

RD-1 - One acre per dwelling unit

RD-2.5- 2.5 acres per dwelling unit

RD-5-5 acres per dwelling unit

RD-10-10 acres per dwelling unit

RD-20-20 acres per dwelling unit

RD-40-40 acres per dwelling unit

One dwelling unit per zoning classification. Minimum lot widths and depths will be the same as RD-40,000 classification as listed in subsection 324.2.

MUDDY CREEK BRIDGE

An Agreement dated September 14, 1978, by and between CARBON COUNTY, WYOMING, a body corporate and politic, by and through the BOARD OF COUNTY COMMISSIONERS of Carbon County, Wyoming, hereafter referred to as COUNTY and G. FRANK SMITH doing business as ECM CONSTRUCTION DIVISION, 1115 Cactus Hill Road, Cheyenne, Wyoming, hereinafter referred to as CONTRACTOR: concerning the construction of a fifty feet (50') bridge over Muddy Creek located about $\frac{1}{2}$ mile north and $\frac{1}{2}$ mile east of Baggs, Carbon County, Wyoming, was executed and placed on file in the Office of the County Clerk.

SARATOGA MEDICAL CLINIC

The Saratoga Carbon County Joint Powers Board met with the Commissioners to discuss the need for a medical facility in the impacted Platte Valley which will serve a population of 5,000 citizens in Carbon County. This would include inhabitants of Encampment, Riverside, and Saratoga, as well as ranchers, and some seasonal population.

The Joint Powers Board made a loan application to The Wyoming Farm Loan Board and the Commissioners agreed to negotiate an agreement whereby that in the event the clinic is vacant, or has a greater vacancy rate than anticipated, during the first 5 years, the commissioners will back the loan and pay the principal and interest due up to \$2,000.00 per month.

There being no further business, the meeting was adjourned until the following day.

HEWARD RANCH ROAD

A letter from Harold M. Johnson, attorney, was received by the Commissioners stating that Charles A. Richards and Clara A. Richards conveyed to Carbon County, Wyoming, for the purpose of establishing a County Road, the W. 30 ft of the E $\frac{1}{2}$ of Sec. 10, Twp. 22, R78W of the 6th P.M., beginning at the south boundary of the section and running to a line parallel with and a distance of 200 feet from the north boundary of said section, more or less. The Commissioners have taken the matter under advisement and no action was taken in declaring the Heward Ranch Road a County Road.

Box 689, Hanna, Wyoming to establish a medical clinic in the Hanna Basin Area in East Carbon County and was executed and placed on file in the Office of the County Clerk.
